1. Installation of Iota Chapter

The following Honorary Members: Faculty Advisor, Dean Neil H. Baxter, H. Roe Bartle, Founder, Henry C. Henrici, President Kansas City Council, and Thomas J. Keane, National BSA Sea Scout Director.

Members of Iota Chapter and their lady friends attended the 17th. annual Boy Scout Round Up at Kansas City, Saturday evening, April 20, 1929.

Iota Chapter is planning to publish a small bulletin about the chapter and its work and about the fraternity.

One project of Iota Chapter is explained. Park College opens Sept. 17th. and from then on Iota Chapter will be doing things. We have planned a feed for the Freshmen boys.

2. Installation of Kappa Chapter.

Kappa Chapter, one of our most active and efficient chapters also started with a banquet and installation, at the Faculty Room of Carnegie Inn, Monday evening, April 29, 1929. Chapter Officers of Beta Chapter at the University of Pittsburgh were guests.

Carl J. W. Long, Grand Master and Junior in the electrical engineering department started the Chapter. The installation was made by Professor B.C. Dennison, Supreme Council Representative, Faculty Advisor and Professor in the electrical engineering Department. T.J. A very good pledge ritual has been developed and information may be received through Alpha Phi Omega, Central office or Carl J. W. Long, G.M., 55 Scout St., Mt. Oliver Branch, Pittsburgh, Pa., One of the duties a pledgee is to pass a written examination and received a grade of 85% on the following;

1. Give the place, date of founding, and name of the founder of the National Fraternity.
2. Quote the object of the fraternity.
3. Give names and titles of national officers.
4. Give names and titles of chapter officers.
5. Give the date of the founding of this chapter and name all the charter members.
6. Give the Greek letter names and locations of all active chapters.

3. Protection of Name, Insignia, and Trade Mark.
by the U.S. Government, through the U.S. Patent office,
Washington, D. C.

The protection of the name of Alpha Phi Omega, insignia, and trade mark, by the U.S. Government at Washington, D.C. at the U.S. Patent Office has been completed. The attorney is Harry H. Benjamin, Esq., Washington Loan and Trust Bldg., Washington, D.C.

The number of the Trade Mark Certificate is 265,052, granted December 10, 1929, signed by Thomas E. Robertson, Commissioner of Patents, and G.P. Tucker, Law Examiner. This protection is for 20 years, subject to renewal for like periods as long as wanted.

Because of two local fraternities named Alpha Phi Omega, in Baird's Manual, this protection is vital. Ours is the only National Alpha Phi Omega. The Locals have been notified of the name protection by our fraternity.

5. Program For Each Chapter To Justify Existence on a College Campus.

6. Protection of the Fraternity through incorporation in Pennsylvania.

In addition to protection by the U.S. Government through the U.S. Patent Office, Washington, D.C. the fraternity is further protected through incorporation in the State where the mother chapter is located, Pennsylvania.

Largely through the efforts of Second National Vice President, Wm. G. Bradford of Butler, Penna., the incorporation was started December 16, 1929, and completed December 30, 1929. With the following signitures;

7. Department of Inspection.

A Department of Inspection has been created to assist with the present plan of inspection by College Faculty Advisor. Everett W. Probst, First National Vice President, 19 Hasbrouck Place, Rutherford, N.J. is in charge.

8. Second and Third National Vice Presidents.

William G. Bradford, 512 Butler Co. National Bank Bldg., Butler, Penna. has been appointed Second National Vice President.

Burdelle S. Cannon, M.D. Medical Arts Bldg., Baltimore, Md., has been appointed Third National Vice President.

9. Department of Extension, Permanency, and Efficiency.

A Department of Extension, Permanency and Efficiency has been created to aid with new chapter extension, and with permanency and efficiency of all chapters. William G. Bradford, is in charge.

10. Department of Standards and Program.

A Department of Standards and Program has been created to set up and maintain high standards in all chapters and to develop and maintain adequate programs. Burdelle Cannon, is in charge.

11. College Approval, Record and Advisor.

Each chapter should make sure that the faculty has officially approved of the fraternity, has a record of it, and a faculty member as an actual and active advisor.

14. Change of your Address.

Please notify Alpha Phi Omega, Box 360, Winchester, Va. of any change in your address so National files may be kept accurately.

15. Endorsement by College Deans and Professors.

Every organization has some critics, even the church, and our fraternity is not exempt but the few critics there are should make us all critical to see where we can strengthen and improve.

The great majority of comments are highly in approval. Practically all deans are favorable. Most professors are, some very enthusiastically. A very few, are not, mostly because they do not understand or have the wrong viewpoint.

A great future is before our fraternity because our foundation is right, and the ideals are the best of the ages.

16. Founders Day, Fifth Anniversary, December 16, 1930.

Plan now to celebrate the fifth anniversary of the fraternity on Founders Day next December 16, 1930. Have a banquet, invite alumni back, and have the Dean and professor, and express the highest ideals of the fraternity. A chapter orchestra could furnish music, some new members could furnish amusement with humorous papers on topics assigned. Make your own plans according to your own conditions. Inform the Supreme Council what you plan to do.

17. Welcome Mu Chapter.

Mu Chapter has been installed at the University of Indiana at Bloomington, Indiana. A detailed account will appear later. Welcome Mu and good wishes for a successful chapter.

18. Welcome Nu Chapter.

Nu Chapter has been installed at Upsala College, East Orange, New Jersey. A detailed account will be given later. Welcome, Nu Chapter, and good wishes for your success, too.

19. Chapters Pending.

Several chapters are pending. College including University of North Carolina, Springfield YMCA College Mass., University of California, University of Michigan, University of Arizona, and others.

20. Chapter Expansion, New Members.

Every chapter should take in new members to keep alive so that when seniors graduate and others leave, there will be enough left to keep the chapter alive. Share the fraternity with as many as possible.

21. International Expansion.

Correspondence with Canada is being made. Only progress can be reported at this time.

22. Chapter Scholarship, Honorary Fraternity.

In keeping with the requirements of many honorary fraternities, one fraternity requires high scholarship and encourages high scholarship. A cup is awarded to the chapter having the best record. Individuals are selected by chapters for high scholarship. Chapter award should be made for the highest ranking Freshmen in the college, to encourage scholarship. Your scholarship is your permanent record. Others will refer to it.
