

- 82 children were reported as abused or neglected
- 18 children were placed in foster homes
- Only one child was adopted from Foster Care
- 36 children dropped out of school
- 73 teens, ages 12-17, used an illicit drug
- 47 teens were arrested
- 5 teens were placed in correctional facilities
- 158,000 children went to bed hungry
- One child died before reaching her first birthday

This is one day in one state. Multiply these numbers by 365 and again by 50, and again by the percentages of youth in our country. Still again add in the concerns of the elderly, the adult homeless, the adult neglected, and the adult premature death rates. And again add in the natural disasters of floods, hurricanes, etc. and we find the statistics overwhelming. The needs of our world are great. Alpha Phi Omega's opportunities are endless!

We in Alpha Phi Omega have the great opportunity to affect the lives of children, teens, adults and seniors in communities and on campuses throughout our nation. We in Alpha Phi Omega have the great opportunity to, as the movie says, PAY IT FORWARD to those who are in most need. We in Alpha Phi Omega have the great opportunity to achieve results at the local level through our efforts as a National Fraternity.

Over the next two years our Fraternity will face and address many issues at many levels. We will be looking at the structure of our national organization to see if there is a better way to serve our members, host campuses and service partners. We will be striving to find more effective and efficient ways of delivering services to our active and alumni membership. We will be introspective in examining the image we project to the world outside our Brotherhood. We will strive to increase meaningful partnerships with like-vision organizations. NATIONAL CONVENTION ACTIONS

LEGISLATIVE ASSEMBLY OF ALPHA PHI OMEGA

DECEMBER 29-30, 2004

ADAM'S MARK HOTEL - DENVER, COLORADO

AMENDMENTS TO THE NATIONAL BYLAWS

Article IV – NATIONAL CONVENTIONS

Section 1 – Membership

Amend to read:

SECTION 1. MEMBERSHIP: The supreme authority of the Fraternity, consistent with the provisions of the Bylaws, shall be vested in the National Convention composed of the Members of the National Board of Directors, the Sectional Chairs or designees, two delegates from each Chapter who shall be Active Members or Chapter Advisors, one Alumni Voting Delegate from each region, and two delegates from each Petitioning Group who shall be Petitioning Members or Petitioning Group advisors. **An Advisor may only serve as a delegate if no Active or Petitioning Members from the Chapter or Petitioning Group are registered at the Convention.** Other Members of the Fraternity may observe but may not participate in floor debate. Members who have not been initiated shall not be allowed to observe debate over rituals.

Article IV – NATIONAL CONVENTIONS

Section 7 – Time and Place

Amend to read:

SECTION 7. TIME AND PLACE. The National Convention shall be held biennially in even numbered years. The time and place for each convention shall be brought as a motion by a reference committee and presented for ratification by the delegates ...

All bids for proposed sites for National Conventions shall be submitted in writing to the National Executive Director **no later than July 1 of the year of the National Convention at which the bid will be presented**; only those bids which meet the Fraternity's minimum prescribed criteria shall be submitted by the National Executive Director to the Chapters and the Board of Directors at least eighty (80) days before the first legislative session of the next convention....

Article V – NATIONAL OFFICERS

Section 1 – Elected National Officers

Amend to read:

SECTION 1. ELECTED NATIONAL OFFICERS. The National Convention shall elect the following National Officers to serve for a term of two years or until their successors shall have been elected and qualified: National President, National Vice President. The National Convention shall also elect six Members to the Board of Directors as Program Directors to serve for a term of two years or until their successors shall have been elected and qualified. **The National President, National Vice President and Program Directors shall be nominated and elected in accordance with the procedures established in the Standing Rules of the National Convention and shall begin their term of office upon adjournment of the final legislative session of the National Convention at which they are elected.**

Article VI – NATIONAL BOARD OF DIRECTORS

Section 2 – Members of the National Board of Directors

Amend to read:

SECTION 2. MEMBERS OF THE NATIONAL BOARD OF DIRECTORS. The National Board of Directors shall consist of the following elected Members: National President, National Vice President, six Program Directors, and eleven Regional Directors, and the following ex-officio Members: National Executive Director, the National Legal Counsel, the National Archivist, the International Relations Director, Past National Presidents, Life Members of the Board, and a representative of the National Council of the Boy Scouts of America. The ex officio Members shall also serve as advisors to the Board and assume responsibility for special assignments on appointment by the National President. Each Member of the Board shall have one vote at meetings of the National Board of Directors, except for the National Executive Director, the National Archivist, and the National Legal Counsel, who shall have voice, but no vote. **Every two years, past National Presidents and Life Members of the National Board will be given the option to elect Emeritus/a status with voice but no vote.** Unless a voting Member of the National Board of Directors is appointed to serve as International Relations Director, the International Relations Director shall have voice but no vote.

Article VIII – FINANCE

Section 4 – Pledge Fee

Amend to read:

SECTION 4. PLEDGE FEE. There shall be a National Pledge Fee of twenty (\$20) dollars to be paid by each new Pledge. The fee shall be nonrefundable and shall be sent to the National Executive Director not later than ten **business** days after the Pledge Ritual is conducted.

Article VIII – FINANCE

Section 5 – Initiation Fee

Amend to read:

SECTION 5. INITIATION FEE. There shall be a National Active Initiation Fee of thirty-five (\$35) dollars to be paid by each new Active member. The fee shall be nonrefundable and sent to the National Executive Director not later than ten **business** days after the Initiation Ritual is conducted.

Article VIII – FINANCE

Section 12

Amend to read:

SECTION 12. FEE FOR ADVISORY MEMBERSHIP: There shall be no registration fee for Advisory Members. The definition of an Advisory Member shall be determined by Article III, Section 2 (4).

Article IX – CHAPTERS

Section 11 – Chapter Permanent Mailing Address

Amend to read:

SECTION 11. CHAPTER PERMANENT MAILING AND ELECTRONIC MAIL ADDRESS. Each Chapter shall maintain a post office box or other permanent Chapter mailing address, **and if feasible a permanent Chapter electronic mail address.**

Article IX – CHAPTERS

Section 6 – Annual Charter Reaffirmation

Omit first sentence after Membership Dues, confirmation of submission of a National Youth Service Day Report and a National Service Week Report.. Amend to read:

SECTION 6. ANNUAL CHARTER REAFFIRMATION. Each Chapter shall annually reaffirm its charter by November 15 by submitting a roster of the Active Members, a roster of the Advisory Members, payment of Annual Active Membership Dues, and certifications that the Chapter is in compliance with the Membership and Risk Management Policies of the Fraternity and is in compliance with the Standard Chapter Articles of Association.

Article IX – CHAPTERS

Section 8 – Chapters in Good Standing

Amend to read:

SECTION 8. CHAPTERS IN GOOD STANDING. A Chapter in good standing is one which yearly meets its financial, administrative, and Annual Charter Reaffirmation obligations to the National Fraternity; is not more than 90 days delinquent in its financial accounts with the National Office; **has confirmation of submission of a National Youth Service Day Report and a National Service Week Report**; has at least one Active Member; and which has not been declared inactive or suspended, or had its charter revoked, or has not otherwise been deemed in violation of the policies or National Bylaws of Alpha Phi Omega; or of the rules, regulations, or policies of its school.

Article IX – CHAPTERS

Section 3 – Issuance of Charters

Amend to read:

SECTION 3. ISSUANCE OF CHARTERS. ...At the National President's discretion, the approval of the National Board of Directors may be by mail ballot with the unanimous written consent of Board Members responding within **ten business** days of the date the petition information is mailed to all Board Members. Chapters shall have **ten business** days from the date the petition information is mailed to them for their vote to be received at the National Office....

Article X – SECTIONS

Section 2 (3) – Sectional Representatives

Amend to read:

(3) SECTIONAL REPRESENTATIVES. Sectional Representatives **may** be appointed by the Sectional Chair and approved by the Chapter or Chapters to which they are assigned. Their terms shall be concurrent with the term of the Sectional Chair. A Sectional Representative may serve more than one chapter.

Article XI – REGIONS

Section 1 (3) – Realignment

Amend to read:

(3) REALIGNMENT. The National Board of Directors shall have a census of the active Chapters taken every six years, beginning in 1998, and being completed at least six (6) months prior to the National Convention to allow dissemination to the Chapters. The National Board must submit Regional Boundaries to the National Convention that contain as practical an equivalent number of Chapters as reasonable geographic alignment of Sections allow. Chapters involved in any

change shall be notified in writing at least eighty (80) days **before the first legislative session of the next National Convention.**

Article XI – REGIONS

Section 2 – Regional Leadership

Amend to read:

SECTION 2. REGIONAL LEADERSHIP.

...Nomination and election of Regional Directors shall take place in Regional Meetings at National Conventions **in accordance with the procedures established in the Standing Rules of the National Convention.** Only registered delegates entitled to vote, representing Chapters within the appropriate region, may nominate and elect their Regional Director. **Regional Directors' term of office shall begin upon adjournment of the final legislative session of the National Convention at which they are elected or upon their election, whichever is later.** Regional Directors may be impeached pursuant to Article VI, Section 9.

Article XII – ALUMNI

Section 2 (4) – Local Alumni Associations

Amend to read:

(4) Each recognized local Alumni Association shall annually reaffirm its recognition by January 15 by application to the National Alumni Relations and Internal Volunteer Development Committee. New associations may apply for recognition at any time. **Initial recognition for an Alumni Association or annual reaffirmation of recognition shall consist of the filing of the required forms with the National Alumni Relations and Internal Volunteer Development Committee. Recognition must be certified or rejected by the National Alumni Relations and Internal Volunteer Development Committee within one month from the receipt of the properly prepared forms.** The fee for formal recognition will be fifteen (\$15) dollars.

Article XII – ALUMNI

Section 2 (4) – Local Alumni Association

Amend to read:

(4) Each recognized local Alumni Association shall annually reaffirm its recognition by January 15 by application to the National Alumni Relations and Internal Volunteer Development Committee. New associations may apply for recognition at any time. The fee will be fifteen (\$15) dollars. **The minimum requirements for initial recognition will be no fewer than five alumni members. Additional requirements for alumni associations may be established at the discretion of the National Alumni Relations and Internal Volunteer Development Committee with majority approval of the National Board of Directors.**

AMENDMENT TO THE STANDARD CHAPTER ARTICLES OF ASSOCIATION

Article X – REGISTRATION OF PLEDGES, ACTIVE MEMBERS, AND ADVISORS

The officers of this Chapter shall cause Pledge Membership applications and the required National Pledge fees to be mailed to the National Office not later than ten days after the Pledge Ceremony. The officers shall also cause applications for Active Membership and the required National Active Initiation fees to be mailed to the National Office not later than ten days after the Initiation Ceremony. Any initiation not followed by the registration of Pledges or Active Members with the National Office shall be null and void. The officers of this Chapter shall submit the required advisor registration form within ten days of adding an advisor to the Advisory Committee. **No fees are required for Advisory Members.** In addition, the Officers of this Chapter shall submit the required Annual Active Membership Dues and confirm the Advisory Members no later than November 15.

RESOLUTIONS

Alumni Relations and Internal Volunteer Development ADVISOR'S GUIDE

Whereas, the current Advisor's Guide only provides a very general description of the chapter advisor position, and Whereas, Chapters and advisors are in need of more clarification of advisors' duties and expectations, and Whereas, Chapters are in need of additional advisor recruitment, retention, and educational aids, Be it resolved that the National Alumni Relations and Internal Volunteer Development Committee revise the Advisor's Guide to address these issues at the advisory level. Be it further resolved that the National Alumni Relations and Internal Volunteer Development Committee develop and create reference materials specifically for the chapter leadership to further educate them in what to expect from their advisors, and how they can better utilize their advisors.

ALUMNI ANNUAL DUES

Whereas, there is currently an impression that Alumni Associations receive little in return for those dues, and Whereas, we can utilize our internal volunteer network and the National Alumni Relations and Internal Volunteer Development Committee, as well as additional fundraisers, to provide many services with little cost, if any, to the Fraternity, Be it resolved that the National Alumni Relations and Internal Volunteer Development Committee develop and implement a plan to provide additional support and services for properly recognized Alumni Associations. Be it further resolved that as part of developing and implementing a plan for providing additional support, the National Alumni Relations and Internal Volunteer Development Committee shall consult with the properly recognized Alumni Associations to determine their needs. Be it further resolved as a minimum level of support for recognized Alumni Associations, including but not being limited to, being provided with copies of the National Bylaws and other pertinent national documents and publications, such as the Chapter Bulletin, and also receiving access to the National Fraternity Database for assisting in membership expansion and maintenance, in the same manner that chapters have access to this information.

Awards and Appreciation

THE PHYLLIS CHURCHILL TENNEY EXCELLENCE IN ADVISING AWARD

Whereas, the Phyllis Churchill Tenney Excellence in Advising Award was established at the 2000 National Convention in Philadelphia; Whereas, Phyllis Churchill Tenney (Mrs. T) was an advisor to the Phi Epsilon Chapter at Maine Maritime Academy; Whereas, the procedures established for the conferring of the award are vague; Be it resolved, that the National Vice President, in the role of Chair of the National Awards Committee, direct the National Alumni Relations and Internal Volunteer Development Committee to develop guidelines and standards for conferring the Phyllis Churchill Tenney Excellence in Advising Award in the future with the standards being similar to those established for National or Alumni DSKs; Be it further resolved that active brothers and recently involved alumni of Phi Epsilon chapter who knew Mrs. T be involved in the development process as the authors of the legislation which created the award at the 2000 National Convention in Philadelphia; Be it further resolved that the Phyllis Churchill Tenney Excellence in Advising Award be conferred at National Conventions, and to be presented at conventions only; in descending order of the National, Regional, then Sectional Conference, depending on the recipients availability to attend such conference; Be it further resolved that the award be conferred upon only one recipient at each National Convention, Be it further resolved that these standards be available for determining the recipients of the Phyllis Churchill

Tenney Excellence in Advising Award at future National Conventions.

NATIONAL MAN MILE AWARD

Be it resolved that the National Fraternity create and adopt a National Man Mile Award to recognize those chapters that have accumulated the most "man miles" in traveling to a National Convention. Man miles are calculated by counting the number of active brothers and advisors from a chapter in attendance at a National Convention and multiplying that number by the distance in miles from the chapter's campus to the Convention site. The number of man miles would be calculated for every chapter attending a National Convention, and the chapter with the greatest total would be named the recipient of the award. The Man Mile Award would be presented every two years, in conjunction with the Alpha Phi Omega National Convention, beginning in 2006.

Be it further resolved that the National Man Mile Award be named in honor of John S. Grossi, in remembrance of his exemplary effort in service to our fraternity as a brother of Omicron Iota Chapter; as Section 94 Chair, from 1995 to 1999; as an honorary brother of Phi Epsilon Chapter; as a volunteer staff member in various Sectional, Regional, and National capacities; and as an advisor to Theta Zeta Chapter.

CONVENTION AWARDS COMMITTEE

Be it resolved that the National President appoint a committee to document Convention Awards procedures including which committee receives which nominations, what is to happen after recipients are decided upon, what happens to the list of award recipients after the committees have reached their decisions, make any necessary clarifications to existing award descriptions, and anything else as deemed necessary.

CORPORATE ENDORSEMENTS

Be it resolved that all future corporate endorsements or sponsorships entered into by Alpha Phi Omega will require an affirmative vote by a 2/3 majority of the voting members of the National Board of Directors. The policy applies to the national level and does not constrain individual chapters, sections or regions.

International Relations

DR. LIBRADO I. URETA

Be it resolved that Alpha Phi Omega, National Service Fraternity, honor brother Dr. Librado I. Ureta, for his outstanding contribution in the founding of the Alpha Phi Omega-Philippines International Inc. A delegate will present a plaque to the National President or acting president of Alpha Phi Omega Philippines at the 2005 national Philippines convention from Alpha Phi Omega, National Service Fraternity, in attendance at the conference, to be placed in their national office.

FUNDING FOR ACTIVE BROTHERS TO ATTEND CONVENTIONS

Be it resolved that Alpha Phi Omega National Service Fraternity investigates the feasibility of co-sponsoring by Alpha Phi Omega, National Service Fraternity, Alpha Phi Omega - Philippines, Alumni Council of North America, International Council of Alpha Phi Omega, and the Dr. Librado I. Ureta Foundations, Inc., by funding active brothers to future National Conventions in the Philippines and the United States.

INTERNATIONAL SERVICE PROJECTS

Be it resolved that Alpha Phi Omega considers international service projects, but not limited to, Alpha Phi Omega, National Service Fraternity, Alpha Phi Omega Philippines, and the International Council of Alpha Phi Omega. Consideration for international projects must

include, at a minimum, evaluation of fiscal responsibility, a timeline, a strategy, and details of any partnerships with other organizations for the execution of the project.

Leadership Development APO LEADS

Be it resolved that the Leadership Development Committee work closer with Alumni Relations and Internal Volunteer Development Committee to better integrate the skills learned in APO LEADS at an alumni and advisory level.

Be it resolved that the Leadership Development Committee shall create rewards for individuals who have successfully completed all courses of the APO LEADS program.

Be it resolved that the Leadership Development Committee establish a program for recognizing exemplary participation by chapters in APO LEADS.

CHAPTER PROGRAM PLANNING CONFERENCE

Be it resolved that the Chapter Program Planning Conference (known hereafter as CPPC) revision committee continue in their efforts to restructure the CPPC manual. Be it further resolved that this initiative be a high priority for the Leadership Development Committee.

COMPREHENSIVE REVIEW

Be it resolved that the Leadership Development Committee shall annually provide a comprehensive review of the leadership development program that will be made available to chapters including tracking the number of members that have completed each APO LEADS component.

RESTRUCTURING OF LAUNCH

Be it resolved the Leadership Development Committee research restructuring the Launch course. This should have a particular emphasis on streamlining the content of the course, developing a more interactive course, and tailoring it to individual chapters.

MARKETING STRATEGY

Be it resolved that Alpha Phi Omega develop an internal leadership development marketing strategy, which should be the committee's highest priority. Such strategy should include the promotion of leadership development resources, emphasizing APO LEADS, and targeting advisors individually.

FEEDBACK SYSTEM

Be it resolved that the Leadership Development Committee further develop a comprehensive feedback system in order to monitor and enhance its leadership development programs.

Membership & Extension

MEMBERSHIP BOUNDARIES

Be it resolved that the convention charges the National Membership and Extension Committee to draft appropriate definitions and submit legislation to the 39th National Convention in 2006 to clarify the boundaries between the types of membership. Specifically, boundaries between ALUMNI MEMBERSHIP, ACTIVE

MEMBERSHIP, ASSOCIATE MEMBERSHIP, and members who are in good standing with their institution of higher education, but cease to meet the requirements for ACTIVE or ASSOCIATE MEMBERSHIP, or who in the past have met the requirements for ALUMNI MEMBERSHIP, but who now meet the requirements for one of the other types of membership.

DIVERSITY TRAINING

Be it resolved that the 2004 National Convention directs the Diversity/Inclusion Sub-committee of the Membership and Extension Committee to continue to develop and make accessible diversity training programs, diversity recruitment manuals, and to submit one article for each issue of the Torch and Trefoil related to increasing diversity in individual chapters.

National Organization

REGION I AND II

Be it resolved that the boundaries of Region I and Region II shall be defined as follows:

Region I shall be composed of the states of Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, Rhode Island and Providence Plantations, and Vermont; and all counties of New York including and to the southeast of Orange and Putnam.

Region II shall be composed of the state of Delaware; all counties of New York including and to the northwest of Dutchess, Sullivan, and Ulster; and all counties of Pennsylvania including and the east of Bedford, Blair, Centre, Clinton and Potter.

Be it further resolved that the resolution shall take effect immediately upon its adoption.

Nominating

Be it resolved that the National President and the National Board of Directors shall create a Task Force to evaluate the feasibility of having an active member advisory board to the National Board of Directors by or at the February 2005 National Board of Directors meeting.

Be it further resolved that this Task Force will have significant representation from active members from various regions.

Be it further resolved that the Task Force shall issue a report to the National Organization Reference Committee at the 39th National Convention of Alpha Phi Omega.

Rules & Credentials

REGIONAL ALUMNI VOTING DELEGATES

Whereas, there is no standard process for electing and credentialing Regional Alumni Voting Delegates;

Whereas, the standardization of these processes would help on both the regional and national level;

Therefore be it resolved that National Convention recommend that the National President appoint a task force to further examine the process of electing and credentialing the Regional Alumni Voting Delegates and recommend a standardized process.

Service & Communication

NATIONAL SERVICE WEEK

Be it resolved that the National Service Week Program of Emphasis for 2005-2006 be "Safer Homes and Stronger Communities."

In addition, be it further resolved that the Alpha Phi Omega National Service Week theme for November 6-12, 2005 be "Making Safer Homes" to promote the health and safety of families; and that the theme for November 5-11, 2006 be "Building Stronger Communities" to promote community involvement. "Making Safer Homes" includes, but is not limited to, projects addressing domestic and sexual violence, fire safety, substance abuse, child welfare, and emergency preparedness. "Building Stronger Communities" includes, but is not limited to, projects addressing homelessness, supporting public safety workers, community food banks and soup kitchens, poverty education and prevention, and disaster relief.

DEAN ARNO NOWOTNY NATIONAL SERVICE AWARD

Be it resolved that the National Service Committee revisit the Dean Arno Nowotny National Service Award to develop standards and/or a template for the application.

Scouting & Youth Services

SCOUTING AND YOUTH SERVICES DIRECTORY

Whereas, one of the cardinal principles of Alpha Phi Omega is service, one of our four fields of service being that of service to the community;

Whereas, the Alpha Phi Omega National Pledge Manual reads, "Frank Reed Horton's purpose was to make Alpha Phi Omega a college organization that cooperated with all youth movements, especially Scouting";

Whereas, the progress of Alpha Phi Omega's Scouting and Youth Services program is contingent upon the information resources made available to individual chapters;

Whereas, chapters are often lacking in the information resources necessary to conduct effective Service to Scouting and Youth programs;

Whereas, better relationships between Alpha Phi Omega chapters and local youth service organization will yield a stronger service program for chapter and facilitate the growth and development of the youth of our nation;

Be it resolved that Alpha Phi Omega will create and make available a directory that should contain a list and descriptions of service projects done with Scouting and Youth Services organizations; the contact information for local clubs and councils of Scouting and Youth Service organizations; and a list of chapters who have successfully collaborated on said projects.

Be it further resolved that the aforementioned directory should contain maps of the locations of various Scouting and Youth Services clubs and councils and suggest resources for chapters to find Scouting/Youth Services Advisors.

TIME & PLACE

The Time and Place Committee recommends that the 2006 National Convention be held December 27-30, 2006 in Louisville, Kentucky.
