

PRESIDENT'S MESSAGE BY MAGGIE KATZ, NATIONAL PRESIDENT

Brothers,

2008 was a great year during which Alpha Phi Omega accomplished many great things. As proud as I am of all that has been done and all the individual and group efforts that made it possible, we need to focus on the future and what it will take to tap the Fraternity's unlimited potential.



We need what I call the ABCs – Accountability, Brotherhood and Collaboration. **Accountability:** Say what you mean and mean what you say. If you promise to do something, do it. As Past President Jack McKenzie says, "Taking the job is voluntary, doing it is not." Follow through or let someone know if you need help or think you may fall short. **Brotherhood:** Always treat each other as family. If your family is anything like mine, that doesn't mean we always get along. However, it does mean that we take care of each other, we treat each other with respect and we can disagree without being disagreeable. **Collaboration:** Work together for synergy, where the whole is greater than the sum of its parts. We can do more together than separately, and we all benefit when new ideas and different perspectives are brought into the mix. Plus, it is a great way to help others develop as leaders.

So, to what do we apply the ABCs?

We need to keep our focus on more healthy chapters. That means more tools for our chapters and local leaders. More skills training, more resources available online, more development of alumni volunteers, more contributions, more service projects in our database, more advertising materials, more communication within the Fraternity.

We need to raise APO's profile in the community. I want students arriving on campus primed to join APO. They should already know about the Fraternity and be looking for a way to get involved. When prospective employers see Alpha Phi Omega on a resume, they should know what it is. We need to increase awareness of the Fraternity to the public-at-large.

We need to find new ways of truly engaging our alumni to keep more of them involved with the Fraternity after graduation. There need to be opportunities to stay connected that fit into the ways lives change after college. Not everyone can or should make the kind of commitment that the Board of Directors, section leadership and advisors make. There needs to be options that are more family-friendly and provide value to our alumni. We also need to do a much better job of helping our brothers understand that membership is a lifetime commitment.

We must make APO more diverse, both within our chapters and nationally. By diverse I mean more than just race or gender. We need people from all walks of life – different socioeconomic groups, different religious and political affiliations, even different class years and majors. Greater diversity brings greater perspective, new ideas, more understanding and helps us meet our Founder's goal of bringing

peace to the world. Each of our chapters should be a crosssection of their campus, including everyone interested in Leadership, Friendship and Service. We must all reach out to those around us, making sure there is room for all and that everyone feels truly welcome. We face this same challenge as a Board and must step up our efforts to attract new, diverse individuals rather than recruiting from the same old spots. We can all make an effort to encourage those around us to get more involved, especially those from underrepresented groups.

We need to look at the way we do business and re-examine everything. As Plato wrote, "The unexamined life is not worth living." *Because we've always done it that way* should never be the reason we do anything. Change just for the sake of change is not wise either; however, everything should be reviewed on a regular basis and reassessed to ensure it still helps us reach our goals, which should also be reviewed routinely. We need to foster continuous improvement by engaging in critical self-evaluation as individuals, as a fraternity and as a Board of Directors. The Board has already begun a review of our national goals to ensure they still represent the proper direction for the Fraternity. The next step is to look at the structure of the Board to ensure we are designed to meet our goals in the most effective manner.

We have a lot of work ahead of us. It's going to be another busy, exciting year for Alpha Phi Omega, full of improvements and growth and, as always, Leadership, Friendship and Service.



Legislative Assembly of Alpha Phi Omega: Actions of the 2008 National Convention

AMENDMENTS TO THE NATIONAL BYLAWS

The following articles in the National Bylaws were amended by the National Convention:

Article VIII – Finance

Section 14 – Annual Insurance Fee The amount of the annual insurance fee is not to exceed \$7 and will be set annually by the Board of Directors on or before August 1.

Article IX – Chapters Section 18 – Finance and Property

The language of this article was adjusted for clarity purposes by the Convention. The financial records of each chapter must now be reviewed (formerly "audited") by an official approved by the institution in which the chapter is located.

Article XII – Alumni Section 2 – Local Alumni Association

Each recognized local alumni association is required to reaffirm its recognition annually by May 15.

Article V – National Officers Section 6 – Duties of the National Program Directors &

Article VII – National Committees Section 6 – Duties of the National Service and Communication Committee &

Article VII – National Committees Section 8 – National Scouting and Youth Services Committee

Communication was removed from Service and Communication as it pertains to the Program Director position, as the National Office now employs a Director of Communications to handle the responsibilities related to the Communications title.

Article VI – National Board of Directors

Section 4 – Membership of the Executive Committee Membership of the Executive Committee of the Board of Directors was restructured and now consists of the President as Chair, the Vice President, the National Finance and Operations Director, one other Program Director, two regional directors, and as ex-officio, nonvoting members, the Executive Director, the National Legal Counsel and the Immediate Past National President.

The second Program Director on the Executive Committee will be elected by a majority vote of the Program Directors. The regional directors will be elected by a majority vote of the regional directors. The election will take place at the first Board of Directors meeting following the close of the National Convention. The term of the elected Executive Committee will be two years.

Article VI – National Board of Directors

Section 6 – Board Meetings "Currently elected" was removed from this section when it appears before "voting members of the Board of Directors."

Article X – Sections

Section 2 (5) – **Sectional Leadership** The Convention decided that sectional officials can be impeached for nonfeasance, in addition to misconduct or malfeasance in office.

Article VI – National Board of Directors

Section 9 – Impeachment The Convention decided that members of the Board of Directors and other elected officials of the Fraternity, including regional officials, may be impeached for nonfeasance, in addition to misconduct or malfeasance in office.

AMENDMENT TO THE STANDARD CHAPTER ARTICLES OF ASSOCIATION

The Standard Chapter Articles of Association were updated by the Convention in accordance with the amended changes to the National Bylaws.

RITUALS & TRADITIONS

The Convention made minor changes to the Initiation Ritual to clarify directions for those performing and participating in the Ritual. An optional Big Brother revelation ceremony was also approved by the National Convention.

RESOLUTIONS

The following resolutions were passed:

- 1) The Fraternity will create a Local Alumni Association Distinguished Service Key.
- 2) The Board of Directors will adjust the timeframe for regional alumni voting delegate selection to require a 14-day minimum, 60-day maximum due date prior to the opening of the National Convention.

- 5) The current Fraternity Membership Policy, Risk Management Policy and National Pledging Standards be included in all future printings of the National Bylaws booklet.
- 6) The Board of Directors will clarify on paperwork and all published materials for the Fraternity the relationship between Life Membership and active membership in order to minimize confusion between the two.
