Service. The first among equals of our Cardinal Principles, this unassuming word carries a lot of freight in Alpha Phi Omega.

For many of us, the attraction of serving others was our main reason for pledging. All the other ideals and vows were just window dressing, although they took on more and more meaning as we learned that the delivery of service required friendship and leadership and all the rest.

But in our Fraternity, even our understanding of service changes over time. One early realization for most brothers is that service to others is service to oneself. The process of planning and motivating and accomplishing that is needed to serve effectively develops the very same traits and skills that are needed in every field of endeavor. Thus, Alpha Phi Omega brothers get an education that is far more complete than many other students. Also, there is a kind of satisfaction that can only be derived from selfless action, but that APO'ers experience directly and clearly.

Paradoxically, a person who desires these benefits of service can only get them by not trying. We serve, not because of what we gain, but to share in the most meaningful way we know. The best servers, the best brothers, are those who tirelessly try to give to others what they perceive themselves to have been given—opportunity, resources, time, knowledge, or whatever. The irony is that one can never catch up on the debt. More acts of giving simply lead to more

FALL PLEDGE CLASS HONOREE

"His care for the Fraternity is exhibited in his leadership and continued volunteerism."

The 1990 Fall Pledge Class Namesake is dedicated to Lorin A. Jurvis, Past National President. Lorin pledged Delta Nu Chapter at Yale University in 1953. He served the Fraternity as Chapter President, Sectional Chairman, Region III Director, and National Vice President. He was elected National President by the 1978 National Convention and served in this capacity for two years.

During his term as National President, he strengthened the Fraternity's relationships with Scouting and college administrators. He provided increased awareness of the Fraternity through a strong public relations program and developed a solid administration through the National Board of Directors.

In the nine years since his term in office, Lorin has continued to serve on the National Board of Directors. He has served on national committees as well as at National Conventions. His care for the Fraternity is exhibited in his leadership and continued volunteerism. Subsequent National Presidents have recognized Lorin's unique capabilities and have assigned him more sensitive tasks with Fraternity business. Honored by the Fall 1990 Pledge Class he will continue to be an inspiration to the thousands of new Brothers of Alpha Phi Omega.

Lorin's dedication to our cardinal principles of Leadership, Friendship, and Service continued throughout his career. After graduating from Yale and attending graduate school at Georgetown University, Lorin enlisted in the United States Army

and served as a Captain of the artillery. In 1959 he began a career of public service with the United States Information Agency. During that time he served in many capacities. His last seven years with that agency he was the Associate Comptroller for Budget and Planning at the Department of State. In that position he managed the budget process for the conduct of the United States Foreign Affairs. After retiring, he was a consultant to various private, governmental and international agencies. Today he is the President, and Chief Executive Officer of Patriotic Education Incorporated, in Washington, D.C., a non-profit, national volunteer membership organization headquartered in Alexandria, Virginia. The corporation publishes books and conducts programs designed to promote and develop constructive citizenship among the people of the United States through education, particularly of youth.

Lorin is active in a number of volunteer organizations. He serves

on the national and local council exploring committees of the Boy Scouts of America and he is a member of the National Flag Foundation and the Military Order of World Wars. Lorin is a Life Member of the Fraternity and was recognized as the National Capital Alumni Association's Man of the Year in 1967. He received the Region III Distinguished Service Key in 1975 and the National Distinguished Service Award in 1976. Continuously active in Scouting since he was a young man, Lorin was recently chairman of the Exploring Leadership Development Task Force at the National Volunteer Training and National Exploring Committees. He served as Exploring Vice Chairman of the National Capital Area Council in Washington, D.C. He has served as an Explorer Post advisor, Scoutmaster, Wood Badge staffer, and in various other leadership roles. He was a Scoutmaster for the 1964 National and 1967 World Jamborees. He is an Eagle Scout, a member of the Tribe of Mic-O-Say and the Order of the Arrow. He is the recipient of the Silver Beaver and Exploring Spurgeon Council Award.

Lorin A. Jurvis, a leader of the Fraternity in the past, certainly one in the present, and from his exhibited dedication, no doubt a leader in the future. For all of this we are very proud to have Lorin A. Jurvis honored as the 1990 Fall Pledge Class Namesake.

CHALLENGE 450

As of August 31, 1990, Alpha Phi Omega had 297 active chapters and three approved charter applications. By August 31, 2000, our goal is to have 450 active chapters.

Establishing a goal is important but without a written plan to achieve it, a goal statement is meaningless. We have embarked on a two pronged program to reach this goal.

The first aspect is to provide additional support for our smaller chapters. This will reduce the number of chapters we are forced to declare inactive. Starting last year, each Regional Director, working with the appropriate Sectional Chairman, has established a "revitalization plan" for those chapters with less than 15 active Brothers. These plans will be revised and updated at least annually. Sectional Chairmen have been requested to focus their efforts on supporting these chapters.

In addition, a special operations manual for smaller chapters has been published. Designed to provide guidance to the leadership of chapters with fewer than 20 active

Brothers, the "Survival Guide for Small Chapters" offers "practical means, methods and materials to help the small chapter create a complete program of leadership development, service and fellowship." It is also designed to assist these chapters to increase their size to a level at which their future is more stable.

The Fraternity will continue to expand these efforts to provide our smaller chapters with encouragement and assistance.

The second aspect of our program is to substantially increase the number of new chapters established each year. The entire extension process, from first inquiry to the granting of a charter, has been revised. Materials have been developed to guide both the students organizing a new chapter and volunteers working with them.

More significantly, we have developed a "National Marketing Plan" to aggressively promote Alpha Phi Omega. We will work to increase awareness of the Fraternity among college administrators, local Scout

Councils, and other youth organizations and students. Campuses in every Section have been targeted for the establishment of a chapter.

These promotional efforts should generate interest in Alpha Phi Omega for existing chapters as well as extension. There are numerous ways for both active and alumni Brothers to become involved in this program. The key to our success will be the number of Brothers who are willing to become involved.

SUMMER BOARD MEETING

The Summer Board meeting of the National Board of Directors was held in Dallas, Texas, July 14, 1990. The following actions were taken:

- Approved Lorin A. Jurvis, Past National President, as Fall Pledge Class Honoree for 1990.

- Patrick W. Burke reappointed as National Executive Director.

- Approved the budget for 1990-91.

- Approved the 1990 Convention budget.

- Appointed Earle M. Herbert, Chairman, and Kay Hairgrove to act as part of a nominating committee to fill two vacancies on the Endowment Trustees whose terms expire in December of 1990.

- Appointed Dr. C.P. Zlatkovich, Past National President, as Chairman of the committee to determine National Distinguished Service Key recipients at the 1990 National Convention.

- Approved two new chapters:

- Omicron Phi, University of Richmond, Richmond, Virginia; Iota Chi, Northern Michigan University, Marquette, Michigan

- Declared four chapters inactive due to non-payment of Annual Active Membership Dues. Those chapters are:

- Lambda Delta, New Jersey Institute of Technology, Newark, NJ; Sigma Omega, Lincoln University, Lincoln University, PA; Pi Epsilon, Alabama A & M University, Normal, AL; Psi Upsilon, Southwestern Oklahoma State University, Weatherford, OK

- Approved new definitions and criteria for national regional and local alumni awards as submitted and amended.

- Authorized the President to sign a publishing agreement with the Taylor Publishing Company of Dallas, Texas to compile a history book of Alpha Phi-Omega from 1925 to 1990.

- Approved the National Officers and committees with long-range goals assignments; to develop action plans for accomplishing these assignments and to present these action plans for review and comments by the 1990 National Convention's Long-Range Goals committee; and for subsequent approval at the Winter 1991 meeting of the National Board of Directors.

- The President authorized Mr. Herbert to negotiate the establishment of an International Service Day or project with Alpha Phi Omega of the Philippines, with the National Board of Directors retaining veto power over the results of these negotiations.

- Approved an amended alcohol policy for the 1990 National Convention. To read:

"All brothers of Alpha Phi Omega are responsible for compliance with laws regarding alcohol consumption;

No alcoholic beverages will be served or consumed at convention functions (i.e. dances, casino nights, talent shows, regional or sectional meetings, etc.);

No alcoholic beverages will be transported or consumed in common or public areas of

the hotel (i.e. halls, lobbies, elevators, etc.) excluding bars open to the public;

Violation of local laws or hotel regulations while under the influence of alcohol will be viewed as a violation of the Fraternity's Convention alcohol policy."

- A committee was appointed to evaluate the role of pledging in Alpha Phi Omega and to develop alternative suggestions for the education of new members if such alternatives are deemed necessary. Fred L. Pollack, Chairman, Bobby M. Hainline, Lorin A. Jurvis, and Wilfred Krenek, members.

- Directed Chuck Bowen, Chairman of the National Scouting & External Relations Committee, to coordinate the presentation of a plaque to the Boy Scouts of America sending congratulations to the National Boy Scouts of America for successful completion of eighty years of service to the youth of America through the principles of Scouting.

- Approved National Certificates of Appreciation be given to: Rick Martin, Section 63 Chairman (Penn.); G. Jay Heim, Retiring Director of the National Eagle Scout Association and liaison for the Chief Scout Executive on the Alpha Phi Omega National Board of Directors; John Meckley, National Chief, Order of the Arrow; Robert Hovey, attorney in Kansas City, Missouri and Sandra Reilly, Administrative Assistant to Alex Lewandowski, National Legal Counsel.

7000 ARROWMEN WELCOME APO!

This past summer, members of the Alpha Phi Omega Scouting and External Relations Committee participated in the 75th Anniversary Conference of the National

Order of the Arrow in Bloomington, Indiana. APO was given several high visibility roles throughout the conference. We were a part of the training sessions and also had the opportunity to host a large reception allowing the opportunity to present APO to Arrowmen—men and women either currently in college or making plans to attend this fall.

Seventy-five years ago the Order of the Arrow was founded at Treasure Island Scout Reservation. The OA is known as the Brotherhood of Honor Campers. It is a fraternal organization with limited membership, both youth and adult, whose foremost program is cheerful service. The OA is based on a tribe of the Lenni-Lenape Indians, an Indian tribe originally from the

Delaware Valley. Many of the ceremonies are rich in heritage and many of the Arrowmen competed in Indian dance and costuming at the conference.

At the opening session Dr. Carl Marchetti, National Chairman of the Conference Committee, received the Alpha Phi Omega Distinguished Alumnus Key. Dr. Marchetti is a graduate of Rutgers University and served four terms as President of Delta Rho Chapter before graduating in 1956. During his distinguished career he has been very active in community affairs. Through Scouting he has received many awards including the Silver Buffalo, which is the highest BSA National Award that can be bestowed upon an adult. In his comments to over 5,000 Arrowmen attending the session Dr. Marchetti charged each of them to continue with the spirit of serve by joining Alpha Phi Omega.

During the five day conference the National Scouting Relations Committee conducted three personal development seminars directly related to APO on how to become a member and how to start a chapter. We also had an exhibit booth and distributed informational brochures about the Fraternity to many of the attendees. Over 500 Arrowmen expressed interest in joining APO or starting chapters at schools where we have no chapters.

Another highlight at the Conference was the opportunity for APO to host a reception for alumni and college age Arrowmen at the University of Indiana's fieldhouse. Bob Barkhurst, our National Archivist, joined the Scouting Relations staff by bringing many of the Fraternity's historical displays. 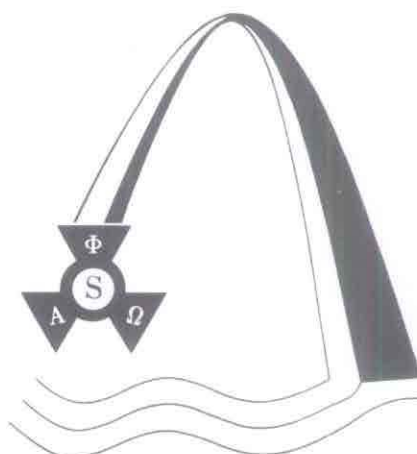
