



Life Membership in Alpha Phi Omega is a means of keeping in contact with the growth and program of our fraternity after college years are ended. Every man in good standing in  $A\Phi\Omega$  either as an active member, advisor, honorary member or alumnus is eligible to subscribe for Life Membership. The fee is \$25.00 as established by vote of the delegates at the 1952 National Convention. This is separate and apart from the pledge and active initiation fee.

Each Life Member receives a permanent subscription to TORCH AND TREFOIL and this gives him regular news about Alpha Phi Omega throughout his lifetime. A special application form may be obtained upon request to the National Office.



Alpha Phi Omega continues to install new chapters each year and there is now much interest on other campuses concerning forming new chapters. Two of our most recent new chapters are pictured on the opposite page. Others will appear in future issues.

Your chapter's Advisory Committee is very important to the success of your program. If you do not have a full Advisory Committee of at least five Faculty Advisors and two Scouting Advisors, select additional men this Fall and have them ready to induct at your next initiation ceremony.

Applications for new pledges should be sent to the National Office within three days after the pledging ceremony is held. This is stipulated in the national constitution. (Require your candidates for pledgeship to fill out the applications and pay the pledge fee not later than the day you conduct the pledge ritual for them. Thus, you will be able to send their applications promptly.)

Arm bands with gold-colored letters of  $A\Phi\Omega$  on blue felt are worn by many chapters when doing service projects. They help identify the organization and are available from the National Office at actual cost of 40c each.

Materials requested from the National Office are shipped the same day the order is received. However, even with immediate shipment we urge chapters to place orders as early as possible for such materials as are needed. Last minute ordering can sometimes cause disappointments because of delay in mail. Please order as soon as you know your needs.

Accurate records are essential to the success of your chapter. These include particularly the records of the Secretary, Treasurer, Historian, Alumni Secretary and Projects Chairman.

## A STORY OF THE FIFTEENTH NATIONAL CONVENTION OF ALPHA PHI OMEGA

Wonderful hosts, an excellent program, helpful training sessions, good attendance and fine fellowship—those few words effectively describe the Fifteenth National Convention of Alpha Phi Omega held in Austin, Texas, August 30 to September 1, 1958. The meeting was a fine success and all who had the privilege of attending participated in an outstanding program. Those who, for some reason, could not attend missed a fruitful occasion.

A fine spirit of brotherhood prevailed and there was a real sense of accomplishment felt by the delegates because of the tremendous service program being conducted by  $\Lambda\Phi\Omega$  throughout the nation.

At this convention, more than 400 members from all parts of the United States took the opportunity to get together, get acquainted, and discuss the several phases of Alpha Phi Omega's program. A great majority of the delegates traveled hundreds, and

even thousands, of miles to join in this convention in the Lone Star State.

National President M. R. Disborough presided ably and was given a big ovation by the delegates for his leadership and devotion as president for the past four years.

Serving as Program Chairman was Dean Arno Nowotny, Past National President, and doing an excellent job as Assistant Program Chairman was Robert J. Hilliard, member of the National Executive Board. Through their advance planning the convention included fun, inspiration and a lot of real values to take back to the chapters.

The Arrangements Chairman was C. C. "Jitter" Nolen, and Phil Paul served as Coordinator of the Host Chapters. Both are Past Presidents of Alpha Rho Chapter and gave superb service at this convention.

Comprising the host committees were Alpha Rho, Zeta Omega, Lambda Xi, Kappa Pi, Kappa Alpha, Delta Omega, Delta Chi, Delta Tau, Delta Pi, Beta Sigma, Beta Pi, Beta Nu, and Beta Delta chapters. They did meritorious work, not only in the advance planning and publicity but also throughout the three days of the convention, including many vital services such as registration, physical arrangements, reception, exhibits, supplies, luncheon and banquet arrangements, entertainment, welcoming, information, church arrangements, ceremonies and sergeant-at-arms.

Serving as Convention Secretary for the seventh time was Rev. Robert J. Payne, member of the National Executive Board, and his work is greatly appreciated by all.

The intricate job of Parliamentarian was very ably handled by Professor Eugene W. Nelson of the University of Texas.

Meetings of the National Committees and a meeting of the National Executive Board were held the afternoon and evening prior to the opening session, and a welcoming smoker provided fun and fellowship under the chairmanship of Jitter Nolen.

#### **Reports of National Officers**

At the opening session, reports of the national officers were significant, giving a record of the past two years accomplishments and offering a basis for growth for the future. Reports were given by E. Ross Forman, National Third Vice President; Irwin H. Gerst, National Second Vice President; William S. Roth, National First Vice President; M. R. Disborough, National President; and Sidney B. North, National Executive Secretary. The National Treasurer's report was presented in the absence of Joseph Scanlon.

Invitations for the 1960 National Convention were presented by representatives of Philadelphia and New York City.

#### **Keynote Address**

The keynote address was by Dr. Robert G. Gordon, Dean of Students of the University of Southern California, Chairman of the Advisory

Committee of Alpha Kappa Chapter, and member of the National Executive Board. His stimulating address was enthusiastically received by all and set the tone for a wonderful convention. His subject was "Pushing Back the Service Barrier," and he gave the delegates a tremendous challenge for the future.

#### **Chapter Presidents are Honored**

The Fellowship Luncheon was dedicated in honor of all Chapter Presidents in attendance at this convention, and an excellent address of tribute to the leadership of the presidents was given by a veteran member of the National Executive Board, Dr. H. F. Pote. A certificate of "Honorary Texas Citizen," signed by Governor Price Daniel, was presented to each president.

Greetings from the National Council, Boy Scouts of America, were extended by Elmaar H. Bakken, Director of Relationships and member of our National Executive Board. He emphasized the close relationship of Alpha Phi Omega and Scouting.

Greetings from the Order of the Arrow were expressed by Phillip W. Robins, National Secretary. He described the areas of cooperation between Alpha Phi Omega and the Order of the Arrow, and a show of hands indicated that more than half of the delegates present are or have been previously active in the Order of the Arrow.

Recognition of the host chapters was given by Phil Paul and the dele-

gates gave tremendous applause for the work of all chapters in the Southwest Section in arranging and conducting this convention.

#### Service Unlimited

The principal address of the luncheon program was by Dr. Willis M. Tate, President of Southern Methodist University. He captivated the group with his stirring address which brought out a splendid philosophy of life. One of his essential points was "There is no limit to the amount of good we can do if we don't care who gets the credit."

"A Happy Career" was the subject of an enthusiastic address by Delmer H. Wilson, Director of the Division of Personnel, Boy Scouts of America, and member of our National Executive Board. He very ably told about the opportunities in the professional service of Scouting and the challenging career of service which Scouting offers.

#### **Valuable Training Groups**

Twenty training groups met during the afternoon and gave thorough consideration to the many phases of  $A\Phi\Omega$  activities and procedures. The group topics included Chapter Executive Committee, Service Committee Operation, Rushing, Duties of the Treasurer, Planning a Sectional Conference, The Secretary's Job, Conducting an Impressive Ritual, Planning Chapter Meetings, The Advisory Committee, How to Organize a New Chapter, Service Projects, Membership, Pledge



## RUSHING

#### A PROSPECTIVE MEMBER'S FIRST IMPRESSION OF ALPHA PHI OMEGA

Although first impressions are not always conclusive, it does help indicate to a prospective pledge the climate in which he may soon find himself.

Why is rushing important? It gives interested prospective pledges the opportunity to see first-hand the caliber of men he will become associated with in affiliating with Alpha Phi Omega as well as to gain an insight into the principles upon which Alpha Phi Omega is founded.

Our principles—Leadership, Friendship and Service—will be evident if rushing is conducted with sincerity, good planning and participation by every brother of the chapter.

Here are three points which are very important in conducting the rush activities.

1. Advance planning. Start planning your program well in advance of the actual smoker. Obtain the names of prospective pledges through use of census cards, from local Scout Executives, camp directors, church leaders, civic leaders and school records, and by personal contact by every member and advisor.

Plan your open meeting in detail so as to eliminate the possibility of failure. A suggested outline was recently sent to each chapter president by the national office. Every brother taking part in the presentations to prospective pledges concerning  $A\Phi\Omega$  should be prepared to answer unexpected questions which may arise. Study the Question and Answer pamphlet and the Manual of Administration in advance,

2. Show sincere friendship. This will either make or break the meeting. It is imperative that all brothers evidence sincere attitude of friendliness, not only toward prospective pledges but to all other members. Friendship, one of the principles of Alpha Phi Omega, should be a natural characteristic of your chapter, and thus you cannot help but convey this feeling to each new pledge. Let's not lose prospective pledges nor active members because of lack of friendship. We care not what the social or economic background of young men may be, only the personal characteristics which he possesses and the motive of service in his

3. Tell the true story of Alpha Phi Omega. The purpose of our fraternity is service. When describing  $A\Phi\Omega$  at your rush meeting, stress that we are a service fraternity and point out that this is a hard-working group of college men with a purpose of service to the campus, community and nation. It is well to point out that we have lots of fun and enjoyment from participating in our numerous projects and fellowship events. What's important is that while having fun, we gain satisfaction from doing something worthwhile for the campus or community, whether it is serving the college administration in a special project or sending a group of orphan boys to camp with money the chapter has earned. The greatest joy and happiness are derived from doing things for

What does all of this have to do with rushing? With a full understanding of the principles and mission of Alpha Phi Omega among our own members, we can do an excellent job of selling our fraternity to others. Alpha Phi Omega is more than a group of former Scouts. It is a service brotherhood. The important thing is to carry out the spirit of the Good Turn during college life.

Knowing that you are responsible for someone entering pledgeship, each has an obligation to the new pledge. Let's personally live up to the principles of our fraternity and thus be a good example to new men.

Notice on the back page of this issue of Torch and Trefoil a list of ways in which each of us can help publicize Alpha Phi Omega.

Plan your rush smoker in good taste. Let no one feel like a stranger. As a brother, each of us has an obligation to meet everyone attending the smoker, offering the hand of friendship and help each prospective member become acquainted with all of the other members and rushees.

Successful rushing depends upon you. Yes, the new pledge is depending upon you to give him a fine start in Alpha Phi Omega.

#### Pledging Materials Available From National Office

Numerous materials are furnished free by the National Office to assist you in pledging new men in your chapter. These include Census cards (for securing a roster of eligible men), "Questions and Answers" pamphlet (for use at rush meetings), Pledge Manual, Torch and Trefoil (extra copies of back issues), invitation cards, bulletin board announcement cards, pledge bid cards (for announcing bids to pledgeship), Ritual pamphlets, and pledge application forms.

Additional materials are also available for chapter use as listed in the August 21 issue of the National Bulle-

tin.

Bill Roth, who became affiliated with Rho Chapter at the University of North Carolina as an active member in 1949, was unanimously elected to the highest office in our fraternity on August 31 at the National Convention in

Ten years ago, Bill helped reorganize Rho Chapter after its wartime lapse and served as president of the chapter. He was elected to the National Executive Board in 1950 and has been the '50 Convention Banquet toastmaster, '52 Convention Advisor to the Time and Place Committee, '54 Convention Program Chairman, '56 Convention Advisor to the Nominating Committee, and 58 Convention Advisor to the National Constitution and By-Laws Committee.

Bill has also served our fraternity as National First Vice President and on the National Extension, Membership, Publications, Distinguished Service Awards and Service Committees.

On the North Carolina campus, Bill was a member of the two highest honoraries—the Order of the Holy Grail and the Order of the Golden Fleece -serving as president of the Grail. He was also president of Delta Upsilon social fraternity chapter, secretary of the Interdormitory Council, Drive Chairman of the Campus Community Chest, and Student Red Cross president. After receiving his Bachelor's degree, he did three years graduate work in the field of Industrial Relations.

While serving on the staff of the University of North Carolina as Student Union Director, Bill was Chairman of the Advisory Committee of Rho Chapter. Among the new chapters he has helped install are North Carolina State College, Wake Forest College, Georgetown University, Lynchburg College, High Point College, The Citadel, East Carolina College, University of South Carolina, East Tennessee State College, A. & T. College of North Carolina and Duke University.

A former District Commissioner, Scoutmaster and Advancement Chairman, Bill is a Woodbadge Course instructor, holder of the Scouter's Key, and recipient of the National Distinguished Service Award of the Order of the Arrow. Currently he is Director of Field Service in Raleigh, North Carolina, heading the efforts of eighteen executives who serve the 20,000 members of the Occoneechee Council, Boy Scouts of America.

A Rotarian, Bill serves as club bulletin editor. He is a Sunday School

teacher at the White Memorial Presbyterian Church, Raleigh.



American Historical Association, gave a very interesting talk about the early history of the Southwest, and Colonel Homer Garrison, Director of the Texas Department of Public Safety, thrilled the delegates and visitors with accounts and experiences of the Texas Rangers. The delegates joined in a hearty songfest led by Jitter Nolen.

Following the barbecue and campfire program, the delegates returned to the hotel for a general business session.

#### **Impressive Memorial Service**

A memorial service in tribute to all members who have passed away since the previous convention was impressively conducted by Dr. Henry Miller, with a memorial prayer being given by Dr. Ray O. Wyland, both members of the National Executive Board.

The National President appointed A. G. Spizzirri, National Editor, to preside at the first legislative session and to introduce reports of four national committees. The Membership Committee report was by the chairman, Dean Arno Nowotny, pointing out the opportunities for future growth. The National Service Committee chairman, Robert J. Hilliard, reported concerning the increase of service throughout the fraternity in the past two years and listed the names of those who have been awarded the National Certificate of Appreciation for outstanding service. The report of the Endowment Fund Trustees was given by President Disborough, telling of the investment of the fund. The report of the Extension Committee was given by the chairman, Dr. Lawrence L. Hirsch, listing the new chapters installed in the past two years and pointing out the numerous contacts which have been developed toward establishment of additional new chapters.

Dr. Hirsch was appointed by the National President to preside at the second legislative session.

#### Report of Constitution and By-Laws Committee

To report the findings of the Constitution and By-Laws Committee, the chairman, Robert G. Knueppel, President of Zeta Beta Chapter of Virginia Polytechnic Institute, was introduced to the convention. He very ably presented the report. There was opportunity for thorough discussion con-

cerning each proposal which had been submitted in advance for changes and additions to the National Constitution and By-Laws. The convention enacted several changes. Presented here is a summary of the major legislation adopted.

In Article III, Section 2 of the National By-Laws, the first paragraph was changed to read, "There shall be a national initiation fee of \$14.00 paid by each new active member. Of this amount, \$4.00 shall be known as a pledge fee. The remaining \$10.00 shall be known as the active initiation fee." This increase in the initiation fee was voted unanimously by the delegates, after extensive discussion, as a means of helping meet the rising costs of operation of the national fraternity and continuing and increasing the service to chapters.

The Scouting prerequisite for membership in Alpha Phi Omega was retained and reaffirmed by overwhelming vote of the delegates.

A section was added to Article VII of the National Constitution to specify the duties of the National Service Committee as follows: "It shall be the duties of the National Service Committee to review new ideas for service projects and make recommendations to chapters, to foster high standards of service in all chapters and to handle nominations for the National Certificate of Appreciation for distinguished service."

A section was added to Article VII of the National Constitution to specify the duties of the National Committee on Supplies and Insignia as follows: "It shall be the duties of the National Committee on Supplies and Insignia to pass on all supplies and upon items bearing the insignia of the fraternity and to be alert to changing times and keeping insignia and supplies up to date. It shall further be the duty of this committee to keep in contact with our official jeweler."

A section was added to Article XVI of the National Constitution as follows: "Chapters of Alpha Phi Omega shall not seek nor accept membership in any association consisting solely of social fraternities."

A section was added to Article X of the National Constitution creating the "Sectional Advisory Committee" for the purpose of advising in the planning of the sectional conference and aiding in any problems which exist in any chapter in the section.

Articles IV, V and VI of the

National Constitution were changed to discontinue the volunteer editor of the Torch and Trefoil and combine the work of Editor and Secretary to become "National Executive Secretary and Editor."

A new clause was added to the constitution to read, "Any member of the National Executive Board who has served twenty years or more on the board shall automatically become a life member of the board.

On Sunday morning the delegates had opportunity to attend churches of their choice. The convention address was at the First Southern Presbyterian Church of Austin, Dr. John W. Lancaster, Minister.

#### Election of National Officers and Board Members

Presiding at the election of national officers and executive board members was President Disborough. He called upon David R. Hotchkiss, President of Beta Theta Chapter at the University of Wisconsin, Chairman of the Nominating Committee, to present the nominations recommended by the committee. There were also other nominations from the floor. Brother William S. Roth of Raleigh, North Carolina, a Past President of Rho Chapter of the University of North Carolina and more recently a National Executive Board member and National First Vice President, was unanimously elected by the delegates as new National Presi-

A colorful high-spot in the threeday program was the Convention Banquet. This was held in the Grand Ballroom of The Stephen F. Austin Hotel, with Dean Arno Nowotny serving in his inimitable way as toastmaster.

The group was enthusiastic, with much singing and fine fellowship.

The attendance award was presented by Dr. Henry Miller. Receiving the award for the greatest number of man-miles traveled by a delegation to attend this convention was Lambda Pi Chapter of La Salle College whose seven delegates traveled a total of 12,600 man-miles one way to attend and participate in this meeting.

Greetings from the Governor of the State of Texas, The Honorable Price Daniel, were extended by Culver Turlington, a Past President of Zeta Omega Chapter of Baylor University.

In a surprise part of the program (a surprise to the recipient) a certificate was presented to Sidney B. North in recognition of twenty-five years service as National Exceutive Secretary. The inscription reads, "In recognition of his outstanding twenty-five years of service to Alpha Phi Omega. The devotion and high ideals which he has exemplified will serve as an inspiration to all who have been associated with him."

The certificate was personally signed by all members of the National Executive Board. A beautiful tray with the same message laminated in glass was presented to be given to Mrs. North. In expressing appreciation for this presentation and for the citation read by Robert J. Hilliard, Sid said that Alpha Phi Omega is more than a fraternity, it is a way of life, and he urged all in attendance to endeavor to live up to the cardinal principles of Alpha Phi Omega, "Be a Leader, Be a Friend, Be of Service."

As Chairman of the National Service Committee, Brother Hilliard then presided at the presentations of National Distinguished Service Awards to five members whose long and faithful service stands out in the annals of progress of Alpha Phi Omega. The keys were presented to Frank R. Horton, Founder of the fraternity; Dean Arno Nowotny, Past National President; Prof. Daniel Den Uyl, Past National President; Dr. H. Roe Bartle, Past National President; and Prof. Kent D. Shaffer, member of the National Executive Board. Assisting in the presentations were the only two previous recipients of the National Distinguished Service Award, Dr. Ray O. Wyland and C. J. Carlson. As the citations were read, the keys with blue and gold ribbons were placed around the necks of the new recipients. A heartfelt round of applause was given by the delegates in each of these awards.

The banquet address was by Dr. H. Roe Bartle, currently Mayor of Kansas City, Missouri, who served for sixteen years as National President of Alpha Phi Omega, from 1931 to 1946. He urged the members to greater service on every campus and in concluding paraphrased the slogan which was popular in England during World War II as he said "There will always be an Alpha Phi Omega and this fraternity shall be free, if Alpha Phi

Omega means as much to you as our fraternity means to me."

The gavel was presented by Past President Disborough to the newly-elected National President, Bill Roth.

In accepting the gavel, Brother Roth expressed humble gratitude to the delegates for their confidence in choosing him as new president and pledged his best efforts toward leading Alpha Phi Omega to new heights. He invited all delegates to give suggestions for improvement and growth of our fraternity.
