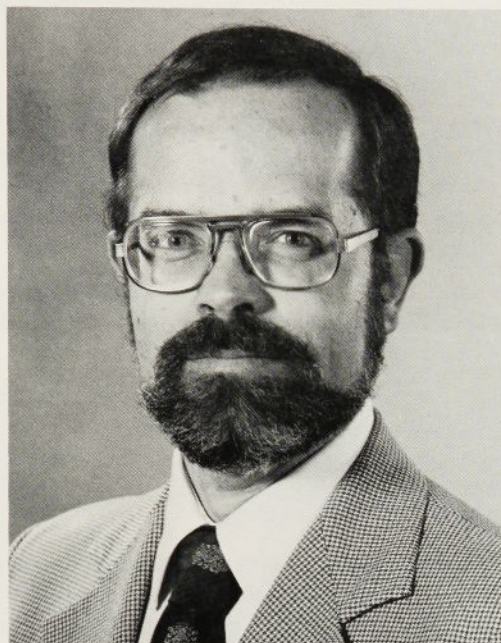

NATIONAL PRESIDENT

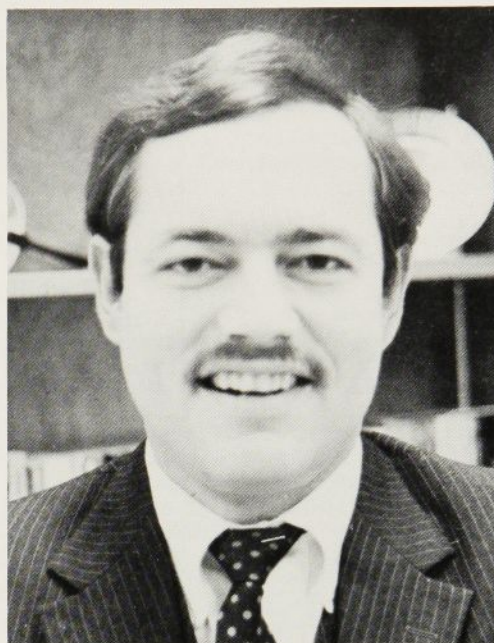
EARLE M. HERBERT

Earle M. Herbert of Los Angeles, California was first elected by acclamation to serve as National President in 1982 and was similarly re-elected to serve a second term (1984-86). He was the first, and only, Brother to serve as Region X Representative until the 1980 National Convention. He was first elected to that position in 1968 and was re-elected in 1972 and 1976. He served as National Vice President from 1980-82.

Brother Herbert was initiated into Chi Chapter at the University of California-Los Angeles (UCLA) in 1959. He served Chi as a chapter officer, receiving the Chapter Distinguished Service Key in 1960. After graduating he served as chapter advisor. Prior to being elected Region X Representative he was a Sectional Representative and Sectional Chairman. He was a delegate to the 1967 Constitutional Convention, and to every Alpha Phi Omega National Convention from 1964 through 1984. He served as National Publications Chairman from 1974-78, as Convention Coordinator for the 1980 Convention, and chaired the Special Committee of Fraternity Standards in 1982.

A Life Member of the Fraternity, he has received many Sectional and Regional honors, including the Regional Distinguished Service Award in 1982. He was also awarded the National Distinguished Service Award in 1978.

He is an administrative officer at Wadsworth Veterans Administration Medical Center in Los Angeles. He has been active in Scouting, serving as both Cubmaster and Scoutmaster. His hobbies include scuba diving and backpacking, and he expresses his musical talents through singing in his church choir. He is single.



NATIONAL VICE PRESIDENT

DR. STAN CARPENTER
Xi Omicron '68

Dr. Stan Carpenter was elected by delegates to the Washington, D.C. Convention to serve as the National Vice President for the 1984-1986 term.

Stan was activated in 1968 into Xi Omicron Chapter at Tarleton State College in Stephenville, Texas. After receiving a bachelor of science degree in mathematics, he was an advisor to chapters at Southern Methodist University and Bishop College in Dallas before moving to Atlanta, where he reactivated Mu Mu Chapter at Oglethorpe University. He also served as Section 72 Vice Chairman and advisor for the 1976 Convention. At the 1976 Convention, Brother Carpenter was elected Region IV Representative. He became a Member-At-Large at the 1978 Convention in Nashville, where he also served as an advisor. From 1978-1984, Stan served as National Service Chairman.

Along the way, Stan earned a master's degree from East Texas State University, and a doctorate in counseling and student personnel in higher education from the University of Georgia. He was Dean of Students at the University of Arkansas at Monticello from 1979-1982; Assistant Director of Development at Texas A&M University until December of 1984; and assumed duties as an assistant professor of Educational Administration and Coordinator of the Higher Education Administration Program at Texas A&M in early 1985. Stan belongs to several professional organizations and has held numerous offices, including president of the Arkansas Personnel and Guidance Association.

Stan is a Life Member, a member of the Founder's Circle, and holds DSKs from Xi Omicron Chapter and Region IV. He lives in College Station, Texas with his wife Noralyn and daughter Susanne.

LET'S PARTY!

It's been a long week, hasn't it? The weekend is here so let's sit back with a few brews and relax. I'm ready to join you myself.

Anywhere, that is, except in a car.

You can't ignore the facts; on any given weekend, every one out of ten cars you see that night is driven by a drunk. Studies by the National Transportation and Safety Board show that half (at least) of all traffic fatalities for individuals in my age (early twenties, college age young adults) group are alcohol related. The public calls it a national tragedy; I call it disgusting.

It can be quite embarrassing when you try to stop someone who is drunk, from driving. I don't care; knock them down and sit on them if you have to, but don't let them get behind that wheel. Drive them home, call a cab, or even let them sleep it off on your couch; it is much better to feel foolish in the morning than not be able to feel anything from the neck down.

I am very glad that organizations like MADD are forcing this problem, which has been tolerated for all too long, into the national spotlight. It is only through their continued pressure that anything is likely to be done about the problem; please support them.

Watch the people at the next party you attend; please notice who, if anyone, appears impaired in the slightest. Don't shrug it off; their life and the lives of others are quite literally in your hands. There is only one thing I can say to someone who knowingly lets another person drive drunk.

I think that they should give you a shovel and make you dig the grave.

CHANGES TO THE NATIONAL BY-LAWS

PURPOSE

Article II

The delegates voted to strike "Law, to develop leadership, to" and replace it with "Law; to develop leadership,".

LIFE MEMBERSHIP

Article III, Section 2, Paragraph (6)

The delegates voted to change this paragraph to read:

(6) LIFE MEMBERSHIP. Life Membership shall be conferred upon any member who contributes to the National Fraternity an amount as specified in Article VIII, Section 8. If requested, life members shall receive a free subscription to the Fraternity magazine, renewable at no cost every five years.

NATIONAL SUSPENSION AND/OR EXPULSION OF MEMBERS AND OFFICERS

Article III, Section 2, Paragraph (9)

The delegates voted to delete the period at the end of this subsection, and add the following:

"and such expelled member shall not be eligible for subsequent pledge, active, associate, advisory, honorary, life or alumni membership in Alpha Phi Omega, unless two thirds of the registered delegates present and voting at a National Convention approve."

VOTING AT NATIONAL CONVENTIONS

Article IV, Section 1

The delegates voted to change this section and substitute it to read:

SECTION 1. MEMBERSHIP. The supreme authority of the Fraternity consistent with the provisions of the By-Laws, shall be vested in the National Convention composed of the members of the National Board of Directors, the Sectional Chairmen, two delegates from each chapter who shall be active members or chapter advisors and one alumni Representative from each region. Other members of the Fraternity may observe but may not participate in floor debate.

VOTE REQUIRED TO ADOPT A MEASURE

Article IV, Section 4

The delegates votes to change this section to read:

SECTION 4. VOTE REQUIRED TO ADOPT A MEASURE. A simple majority of the votes cast shall be necessary to adopt a measure.

ELECTED NATIONAL OFFICERS

Article V, Section 1

The delegates voted to strike the word "period" as it appears in the first and second paragraphs and replace it with the word "term".

DUTIES OF THE NATIONAL EXECUTIVE DIRECTOR

Article V, Section 7

The delegates voted to insert the phrase "work under the direction of the National President and shall", and the phrase "by the President and" in the first sentence of the first paragraph and insert the word "Executive" in the second sentence.

MEMBERS OF THE NATIONAL BOARD OF DIRECTORS

Article VI, Section 2

The delegates voted to change this section to read:

SECTION 2. MEMBERS OF THE NATIONAL BOARD OF DIRECTORS. The National Board of Directors shall consist of the following elected members: The National President, the National Vice President, five Members-at-Large, ten Regional Representatives; and the following ex-officio members: the National Executive Director, the National Legal Counsel, the President of the National Council of the Boys Scouts of America and the Chief Scout Executive or their nominees, past National Presidents, and Life Members of the Board. The ex-officio members shall also serve as advisors to the Board and assume responsibility for special assignments on appointment by the National President. Each elected member and Life Member of the Board and Past National President shall have one vote at meetings of the National Board of Directors, other members shall have voice but no vote.

BOARD MEETINGS

Article VI, Section 6

The delegates voted to insert the word "elected" in the second sentence, and insert the phrase "regularly scheduled" in the third sentence.

NATIONAL ALUMNI COMMITTEE

Article VII, Section 3

The delegates voted to change the first paragraph of this section to read:

SECTION 3. NATIONAL ALUMNI COMMITTEE. The National Alumni Committee shall consist of a chairman, appointed by the National President from among the five elected Members-at-Large, and at least ten alumni members of Alpha Phi Omega, one to be chosen from each region, as nominated by the National Alumni Committee Chairman and appointed by the National President.

NATIONAL SCOUTING RELATIONS COMMITTEE

Article VII, Section 9

The delegates voted to insert the phrase "a Chairman appointed by the National President," in the first sentence.

LIFE MEMBERSHIP FEE

Article VIII, Section 8

The delegates voted to strike "advisor" and replace it with "advisory".

ISSUANCE OF CHARTERS

Article IX, Section 4

The delegates voted to insert the following sentence between the first and second sentence:

"At the President's discretion, the approval of the Board of Directors may be by mail ballot with the unanimous written consent of Board members responding within twenty days of the date the petition information is mailed to all Board members."

SUSPENSION AND REVOCATION OF CHARTERS

Article IX, Section 6

The delegates voted to add the following sentence at the end of this section:

"Following revocation of a chapter's charter by a National Convention, no petitioning group shall be recognized nor chapter chartered at that campus for a minimum of two years after the charter's revocation."

ANNUAL CHARTER REVIEW

Article IX, Section 7

The delegates voted to change this section to read:

SECTION 7. ANNUAL CHARTER REVIEW. Each chapter shall review its charter, in the beginning of the academic year of its educational institution, not later than November 15, according to charter review procedures established by the National Board of Directors.

CHAPTERS IN GOOD STANDING

Article IX, Section 9

The delegates voted to insert the words "and Annual Charter Review" after the word "financial".

NATIONAL ALUMNI ASSOCIATION

Article XII, Section 1

The delegates voted to add the following to the end of the existing section "", and local alumni organizations. The Chairman of the National Alumni Committee shall also serve as the Chairman of the National Alumni Association."

LOCAL ALUMNI ORGANIZATIONS

Article XII, Section 2, Paragraph 1 (C)

The delegates voted to change this subparagraph to read:

(C) Any combinations of alternatives within this section or any other method local organization which local alumni may deem desirable with the approval of the National Alumni Committee.

MEMBERSHIP IN ALUMNI ASSOCIATIONS

Article XII, Section 2, Paragraph (3)

The delegates voted to change the last sentence to read:

"Alpha Phi Omega Alumni Associations shall not grant any form of membership 1) that does comply with the above standards, or 2) to any member expelled from the Fraternity under Article III, Section 2, Paragraph 9."

RECOGNITION FOR LOCAL ALUMNI ASSOCIATIONS

Article XII, Section 2, Paragraph (4)

The delegates voted to change this entire sentence to read:

(4) "All alumni organizations shall apply to the National Alumni Committee yearly for formal recognition. The National Alumni Committee may set a fee for formal recognition."

POWER TO AMEND

Article XIII, Section 1

The delegates voted to change this section to read:

SECTION 1. POWER TO AMEND. The power to amend the Articles of Incorporation, By-Laws, Standard Chapter Articles of Association, rituals, ceremonies, and Toast Song, shall rest in the National Convention."

PROCEDURE FOR AMENDMENT AND VOTE REQUIRED TO AMEND

Article XIII, Sections 2 & 3

The delegates voted to strike "or" before Standard Chapter Articles of Association, and insert "rituals, ceremonies, or Toast Song" after Standard Chapter Articles of Association.

CHANGES TO THE STANDARD ARTICLES OF ASSOCIATION

(Delegates voted to change the following Articles to read:)

ARTICLE III MEMBERSHIP

SECTION 7. ALUMNI MEMBERSHIP. Upon leaving this chapter, all who have held active, advisory, or honorary membership in this chapter shall be recognized as alumni members.

ARTICLE IV OFFICERS

This chapter shall elect a President, one or more Vice Presidents, a Treasurer, and other such officers as the chapter deems necessary. Such officers shall be elected at least annually. Such officers shall be properly

installed by a traditional ceremony according to the official ritual book and as added to by the chapter. This chapter may remove an officer for not meeting assigned responsibilities only in a method prescribed by this chapter's by-laws.

ARTICLE XVIII FINANCE AND PROPERTY (First Paragraph)

The officers of this chapter shall, if required by law, cause an annual return on Form 990 to be made to the Internal Revenue Service in the district in which this chapter is located.

RESOLUTIONS

ALCOHOL MISUSE AND ABUSE

Alpha Phi Omega supports the efforts of alcohol education around the country and encourages each chapter and its members to set an example by promoting responsible drinking whenever alcoholic beverages are present. Alpha Phi Omega also encourages each chapter to support their campus and community efforts to educate the student body and general public regarding the effects of alcohol misuse and abuse.

ACADEMIC STANDARDS

All members are encouraged to promote and maintain the highest academic standards possible. Each chapter should set an example on their campus by encouraging a support system of educational assistance to the pledges and members of the chapter who may need or desire academic help, within the academic guidelines of the university.

INTERNATIONAL YOUTH YEAR PROGRAM

The Fraternity encourages participation in the International Youth Year Program, and all such national and international conferences in the future as deemed worthwhile by the National Board of Directors. Members are encouraged to participate in the United Nations International Youth Conference to be held in Kingston, Jamaica in April 1985. The National Service Committee is to notify all chapters and coordinate a delegation of interested brothers to attend UNIFY Conference and will notify the chapters as to how they can help support the program.

CONGRATULATIONS BSA

In recognition of their 75th anniversary, the Brothers of Alpha Phi Omega extend sincerest congratulations and best wishes to the Boy Scouts of America. A letter of congratulations is to be issued by the National Office and signed by Alpha Phi Omega's president.

LEADERSHIP INDEX

The National Leadership Development Committee is directed to organize an Index of leadership resources which shall include all leadership publications, a synopsis of available workshops, appropriate addresses of workshop and seminar directors, Regional Representatives, and the National office, and other pertinent material. The Index shall be updated twice yearly in September and January.

LEADERSHIP SERIES

The Leadership Development Committee, to make chapters aware of the purposes and availability of the various workshops, shall append the Leadership Series to include the Role-Playing Workshop as prescribed in the Chapter Presidents Workshop. The creation of a Leadership Menu, which is a short description of available workshops, and a supplement about "The Care and Feeding of Advisors", directed towards chapter-advisor relations are also requested.

NATIONAL CONVENTION COMMITTEE

The National President is directed to continue to appoint a National Convention Committee for the planning of the National Convention, and the Board of Directors shall give increased consideration to the recommendations of the Convention Committee.

CAPITAL EXPENDITURE FUND

The National Alumni Chairman strongly urges each alumnus to donate annually to the Capital Expenditure Fund.

SUB-COMMITTEE TO SEEK ALTERNATIVE FUNDING SOURCES

The Board of Directors is strongly urged to appoint a sub-committee of the National Finance Committee for the purpose of seeking and proposing alternative funding sources to meet long and short range capital operating needs of the Fraternity and to provide input and supervision for fund raising programs.

NATIONAL FINANCE COMMITTEE REPORT

The report of the National Finance Committee was accepted by the National Convention. Furthermore, the National Convention wholeheartedly supports the goals and directives of the National Finance Committee.

CRITERIA AND METHODS FOR SELECTION OF AWARDS

The National Alumni Committee will consider and clarify the criteria and methods of selection for the National Alumni Distinguished Service Key and The Distinguished Alumnus Award.

PAYMENT OF ANNUAL ACTIVE MEMBERSHIP DUES

Article VIII, Section 7 of the National By-Laws is interpreted to mean that Annual Active Membership Dues are payable and due on November 15 of each academic year and that a chapter, to remain active and in good standing must remit all dues payable within a period of two academic years.

UTILIZATION OF STANDING COMMITTEES

It is strongly recommended that each chapter utilize standing committees on significant areas of the chapter program, to motivate and involve each member in chapter leadership.

UPDATE OF POSTERS

The National Publications Committee is directed to review, update, and/or redesign the following: Building Blocks Poster, "We Make Smiles" Poster, and the Scouting Poster.

SELECTION OF ALUMNI VOTING DELEGATES

The Regional Alumni Council will prepare a description of the election procedures ascribed to by that Council in selecting a Regional Alumni voting delegate, and such description will in turn be approved by the Regional Representative prior to the election process.

1985-86 PROGRAM OF EMPHASIS

Alpha Phi Omega's Program of Emphasis for 1985-86 will be "Service to Our Nation's Health." The program may include projects such as blood drives, alcohol awareness programs, fundraisers for health-oriented charitable organizations, working with mental institutions, and personal fitness.

DUTIES OF NATIONAL SERVICE COMMITTEE

During 1985-86 the National Service Committee is to promote National Service Day and send out an assistance packet; continue and perhaps expand the *Service Hot Line* as contributions warrant; continue the National Service Essay Contest, making it biennial with topics related to the Program of Emphasis; and continue the Memorial Service Project and compile and distribute to all chapters an assistance packet. Furthermore, the National Service Committee will increase its publicity and promotion of the programs mentioned above.

CHAPTER REACTIVATIONS

Because there currently exists a significant number of inactive chapters and alumni have the knowledge and experience necessary to facilitate chapter reactivation, alumni should take an active role under the direction of the respective Regional Representative in reviving chapters.

CAREER DAY

Since alumni experience can benefit the undergraduate member in career planning and both alumni and undergraduate members can assemble on the chapter, sectional and regional levels to discuss career planning, the National Fraternity supports a Career Day for the betterment of the brotherhood.

ALUMNI SECRETARY

Because alumni provide a valuable source of knowledge and experience, and communication between alumni and undergraduates is necessary, each chapter shall appoint or elect an alumni secretary who is strongly urged to act as an intermediary between the chapter and the alumni.

REFERENCE COMMITTEE ADVISORS AND CHAIRMAN

Reference committee advisors and chairmen shall receive, at least three weeks in advance of a Convention, pertinent information from the National Office preparing them for their roles in the reference committees. It is recommended that the Convention Committee provide for workshops during which these advisors and chairmen may clarify their positions and share ideas in advance of acting in the reference committees.

1986 NATIONAL CONVENTION

The 1986 National Convention will be held in Houston, Texas on December 28, 29, 30, 1986.

JOSIAH FRANK AWARD

Recognition was extended to Omicron Lambda, Calumet College, and Tau, University of Florida, because of their efforts in making presentations to the Josiah Frank Historian's Award. The importance of the Josiah Frank Award in promoting documentation of a chapter's history, and, consequently, the history of the National Fraternity is recognized.
