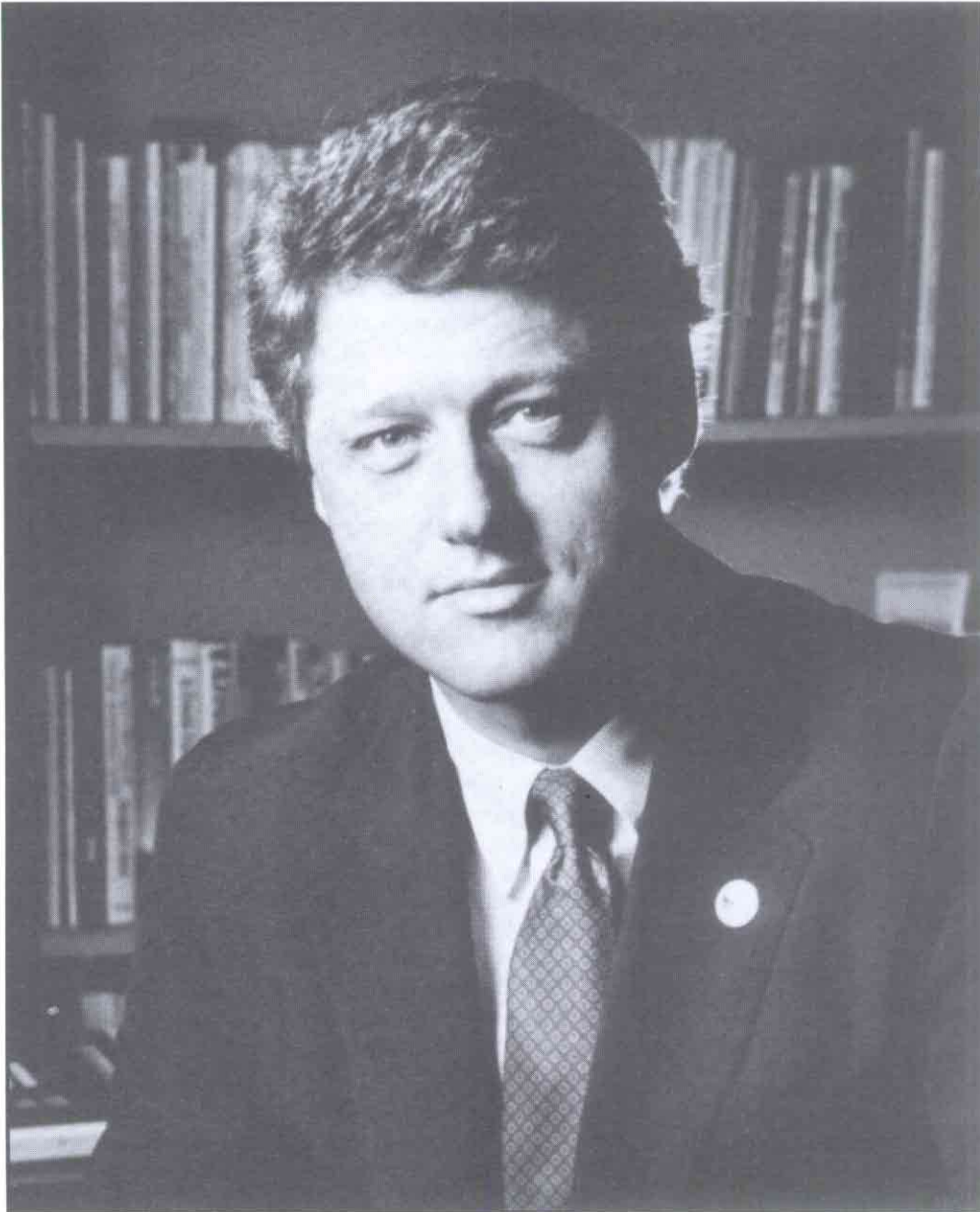

We do that through effective, vibrant, visible service programs — leading the way to service by example.

The recent tragedies of hurricanes Andrew and Iniki aroused the spirit of volunteerism all across America. Communities mobilized, quickly and effectively, to help the victims in Florida, Louisiana and Hawaii. And no one could fail to be touched by the sight of people helping people for no good reason except that help was desperately needed.

But what about America's other tragedies? What about its local needs that don't get national headlines? What about the homeless man or woman down the street? What about the hungry child next door?

Imagine if the energy and selflessness demonstrated so recently in the aftermath of these violent hurricanes happened every day in America's neighborhoods!

Well, Alpha Phi Omega is there.

Yes, we helped in Andrew's aftermath. But it didn't take a natural disaster to mobilize us. Alpha Phi Omega is always mobilized, always helping, always caring, always loving.

Alpha Phi Omega knows that, as terrible as Andrew and Iniki were, the individual "natural disasters" of hunger, homelessness, illiteracy and loneliness are just as devastating in a very personal sense.

We lead the way to service by example — in an unparalleled, unique way that others may copy but never will duplicate.

But, there is another way to lead the way to service — one that even Alpha Phi Omega hasn't really tried yet.

Up to now, we have said that, no matter who you are, if you want to serve, then join us.

But what about those persons who, for whatever reason, don't want to join our Fraternity? What about the members of other student organizations, other fraternities and sororities?

One of the most significant forms of service we can render to the nation is to involve others in service — to inspire and encourage others to give of themselves, to join the struggle because it's the right thing to do, an obligation of citizenship.

Just because other organizations may not have service as their principal objective does not mean that they cannot or should not serve.

Just because a student does not wish to join Alpha Phi Omega does not diminish that person's responsibility to help others or reduce that person's value as a resource for volunteerism.

One goal of every chapter's service program ought to be to promote — in a real way — service by every student or

ganization on campus. "Leading the way to service."

One goal of every chapter's service program ought to be to involve more students in volunteerism. "Leading the way to service."

We *can* do more than just be an example! We have no monopoly on helping others. We must teach others to serve. We must mobilize the youth of America. Our nation needs them.

And, Alpha Phi Omega chapters are uniquely positioned to be the catalyst for service by youth. Students rarely are motivated to action by older people. They will listen to their peers.

*No one* is better positioned, *no one* has greater moral authority, *no one* has a better track record in leading the way — to mobilize college and high school students to service — than Alpha Phi Omega.

Our challenge is not to be the best fraternity in the world — because we are that already — nor to be the most unique, most unselfish student organization in the world — because we are already.

Our challenge is to "export" idealism! To revive the great American tradition of volunteerism among its youth.

Alpha Phi Omega is not for everyone. But service *must be* for everyone. Service may not be everyone's *soul*, but it must be part of everyone's life.

Twenty years ago, the Chief, H. Roe Bartle, spoke at his last convention. Near the end of his speech, he said, "You've got to have love in your heart if you're really going to be a brother of Alpha Phi Omega."

I'd like to add a corollary to that: Love isn't really love until you give it away.

And so I propose that we give away something that means a great deal to us — the ideal of service.

Let us show the world that there is more to life than making money — and that everyone must help make this world a better place in which to live.

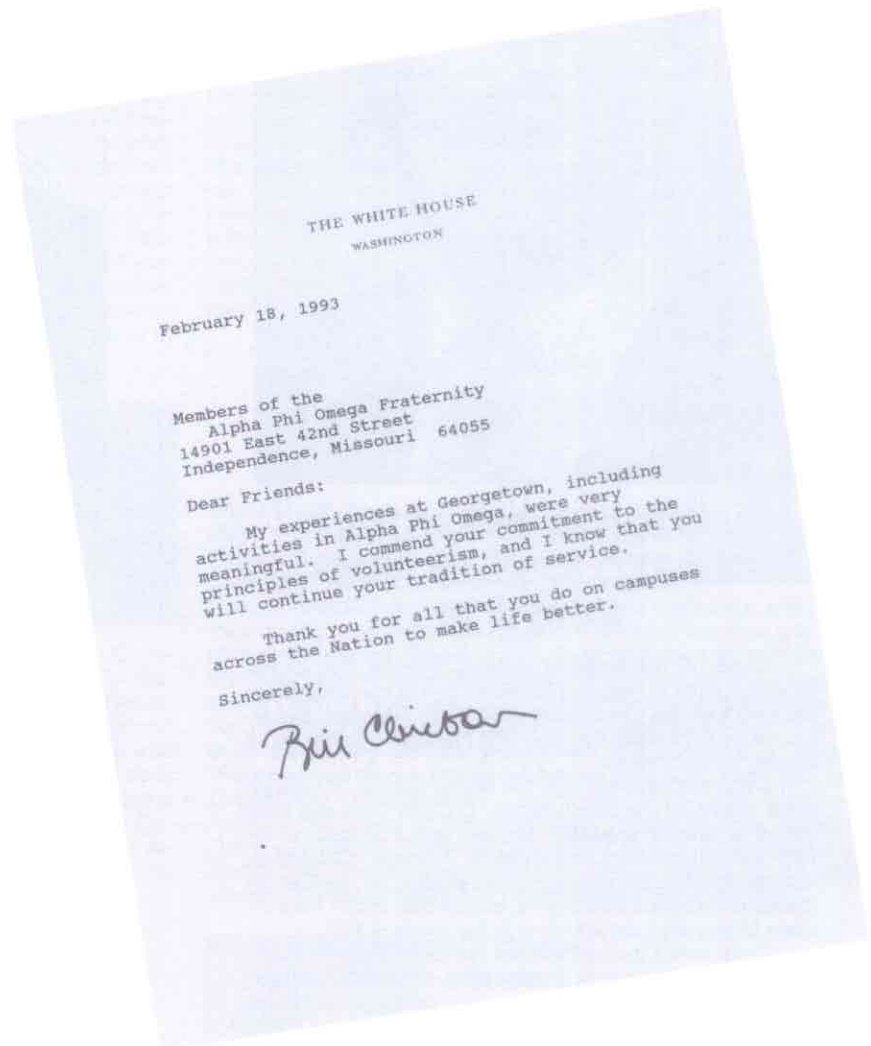

On the morning of January 20, 1993, almost 250,000 members of Alpha Phi Omega had the opportunity to witness a unique event. One of our own fraternity brothers was inaugurated the 42nd President of the United States of America.

On October 18, 1966, a membership application for William J. Clinton was received at the National Office. On October 20, 1966, he was assigned the national number of 95028. His chapter number was 213. As we all know, the President was born August 19, 1946, in Hope, Arkansas, and grew up in Hot Springs, Arkansas. He entered Georgetown in September, 1964. His APO application stated that his course of study would be international affairs. His extra curricular activities included band and intramurals-freshman & sophomore years. Over the years Brother Clinton remained in communication with and provided service to the Fraternity. In particular, as Governor he was the Honorary Chair of our Capital Campaign Fund to build the National Headquarters building.

Gerald A. Schroeder of McLean, Virginia, was elected by acclamation as National President by the delegates to the 1990 National Convention in St. Louis, Missouri, and re-elected by acclamation by the 1992 National Convention in Boston, Massachusetts.

Jerry was initiated into Mu Alpha chapter at Georgetown University in Washington, D.C., in 1966 and later served as chapter president. He was also a delegate to the 1967 Constitutional Convention in Norman, Oklahoma. After completing his undergraduate studies, he received his Doctor of Jurisprudence degree, magna cum laude, from Indiana University Law School in Indianapolis in 1972.

Jerry was Chair of Section 84 from 1977-1981 and served on two National Committees, Minority Concerns (1981-82) and the Special Committee on Fraternity Standards (1982). He was elected to the National Board of Directors as a Member-at-Large in 1982 and chaired the National Membership and Extension Committee. He was elected National Vice President in 1986 and re-elected in 1988.

Since 1977, he has been personally involved in the chartering of four chapters of the Fraternity. He has advised reference committees at the 1980, '82, '84 and '86 National Conventions and was the Advisor to the 1984 Convention in Washington. Jerry is a recipient of the Chapter, Sectional and Regional Distinguished Service Keys. He is a Silver Founders Circle Torchbearer and a Life Member.

Following his graduation from Law School, Jerry served four years with the U.S. Army as a captain in the Staff Judge Advocate Corps. Our President then joined the United States Department of Justice and is currently Senior Attorney in that department's Office of Intelligence Policy and Review. In addition to belonging to several professional organizations, Jerry is a volunteer umpire in three Little League Baseball organizations and is a member of the Virginia State Tournament Umpire Association. He lives with his wife, Betsy, and their three children, Jeffrey, Leslie and Kathryn.

Wilfred M. Krenek was elected by the delegates to the St. Louis, Missouri, Convention to serve as the National Vice President for the 1990-92 term and was re-elected by acclamation by the 1992 National Convention in Boston, Massachusetts.

A 1971 initiate of Alpha Rho chapter at the University of Texas at Austin, Wilfred went on to serve as chapter president. After receiving a bachelor of business administration degree in accounting, he served as Section 42 Chair from 1977-80. # 1992 NATIONAL CONVENTION ACTION

The following actions were approved by the 1992 Voting Delegate Assembly.

## REVOCATION OF CHARTERS

Upon recommendation by the National Board of Directors, the 1992 National Convention revoked the charters of Theta Rho Chapter at Sam Houston State University in Texas and Omega Psi Chapter at Jackson State University in Mississippi for violations of the policies and principles of Alpha Phi Omega, particularly those policies and principles prohibiting hazing.

## AMENDMENTS TO THE NATIONAL BYLAWS

The following changes to the National Bylaws and Standard Chapter Articles of Association were adopted by the 1992 National Convention.

### ARTICLE III — MEMBERSHIP

#### Section 1. OPEN MEMBERSHIP.

**Amended to read:** "Membership in Alpha Phi Omega shall be open to all students, upon the approval of the respective collegiate chapter and after fulfilling the membership requirements prescribed by the National Fraternity and by that chapter."

#### Section 2. TYPES AND CONDITIONS OF MEMBERSHIP, (2) ACTIVE MEMBERSHIP.

**Amended by deleting the words "Boy" and "recognized by the International Association." The revised phrase now reads:** "... who are encouraged, but not required, by their chapter upon activation to be a registered member of any Scout movement; ..."

**Further amended by substituting "an approved membership education program" for "the period of pledge membership,"** which appeared at the end of the first sentence.

#### Section 2. TYPES AND CONDITIONS OF MEMBERSHIP, (9)

**Amended by adding a new subsection as "(9) PETITIONING MEMBERSHIP" and renumbering successive subsections accordingly. The new subsection reads:**

"(9) PETITIONING MEMBERSHIP. Petitioning membership shall be conferred upon enrolled students of an institution of higher education in which a Petitioning Group of Alpha Phi Omega is located and upon selection by the Petitioning Group to participate in the establishment of a chapter of Alpha Phi Omega."

### ARTICLE IV — NATIONAL CONVENTIONS

#### Section 1. MEMBERSHIP.

**Amended by revising the end of the first sentence to read:** "... chapter advisors, one Alumni Voting Delegate from each region, and two delegates from each Petitioning Group who shall be petitioning members or Petitioning Group advisors."

**Further amended by inserting the following as the last sentence:** "Members who have not been initiated shall not be allowed to observe debate over rituals."

#### Section 2. VOTING POWER.

**Amended by inserting the word "voting" before the word "member" in the third sentence, so that the sentence now reads:** "Each voting member of the National Board of Directors and each Alumni Voting Delegate registered at a convention shall have only one vote."

#### Section 7. TIME AND PLACE.

**Amended by revising the second sentence of the first paragraph to read:** "The time and place for each convention shall be brought as a motion by a reference committee and presented for ratification by the delegates in accordance with the following rotation: ..."

### ARTICLE V — NATIONAL OFFICERS

#### Section 6. DUTIES OF MEMBERS-AT-LARGE OF THE NATIONAL BOARD OF DIRECTORS.

**Amend by adding the following to the end of the last sentence:** "or to serve in such other capacity as the President deems is in the Fraternity's best interest."

### ARTICLE VI — NATIONAL BOARD OF DIRECTORS

#### Section 6. BOARD MEETINGS.

**Amended by adding after the third sentence:** "A quorum at all Board meetings shall consist of a majority of the currently elected members of the National Board of Directors."

#### Section 8. BOARD VACANCIES.

**Amended by replacing the previous language with:** "Any member of the Board may resign from the Board by submitting a letter to the National Executive Director. Such resignation by a Past National President or Life Member of the Board shall not constitute a Board vacancy. Vacancies occurring among currently elected members of the Board shall be filled by vote of the remaining members of the Board until the next National Convention. Any person selected to fill a vacancy shall meet the eligibility requirements prescribed in these Bylaws for the predecessor."

### ARTICLE VII — NATIONAL COMMITTEES

#### Section 4. NATIONAL MEMBERSHIP AND EXTENSION COMMITTEE.

**Amended by replacing the second paragraph with the following:** "It shall be the duty of the National Membership and Extension Committee to promote and encourage programs that aid chapters in membership growth, to promote and encourage programs and activities for the enhancement of membership in the Fraternity, to promote and encourage the reactivation of previously voided charters, and to promote and encourage the formation of new chapters."

### ARTICLE VIII — FINANCE

#### Section 6. ANNUAL ACTIVE MEMBERSHIP DUES.

**Amended by inserting "regardless of Life Membership status" at the end of the first sentence and by revising the third sentence to read:** "The definition of an active member shall be determined by Article III, Section 2 (2)."

#### Section 7. LIFE MEMBERSHIP FEE.

**Amended to read:** "Life Membership shall be granted to all undergraduate active members and to alumni members within six months of their obtaining alumni status who are in good standing and have contributed fifty dollars (\$50) in a single sum or cumulatively to the National Fraternity and to graduate, advisory, honorary, and other alumni members who have contributed one hundred dollars (\$100) in a single sum or cumulatively to the National Fraternity. The Life Membership fee, in turn, shall be contributed to the National Alpha Phi Omega Endowment Fund."

### ARTICLE IX — CHAPTERS

#### Replaced Sections 2, 3, and 4 with the following:

**Section 2. REQUIREMENTS FOR ESTABLISHING A CHAPTER.** A charter shall be granted only on a formal petition of fifteen or more students at an accredited college or university. Prior to the issuance of a charter, a Petitioning Group may be established upon a finding by the National Membership and Extension Committee that it would be in the best interest of the Fraternity to do so and after an application for Petitioning Group status is submitted to such committee. The requirements for recognition as a Petitioning Group shall be established by the National Membership and Extension Committee. Should Petitioning Group status be denied, a written explanation of the reasons for denial must be submitted to the National Executive Director, who shall forward it within 14 days to the National Board of Directors and to the group seeking Petitioning Group status. A group which submits an application for charter shall have three or more advisors from the faculty, administration, or staff of the college or university, and one or more Scouting advisors. The group shall meet the published requirements for charter established by the National Membership and Extension Committee.

**Section 3. ISSUANCE OF CHARTERS.** Charters shall be issued by the National Executive Director after the approval of the Regional Director and Sectional Chair for the area in which the Petitioning Group is located and, following submittal of the recommendation of the National Membership and Extension Committee through the National Executive Director, an affirmative vote of two-thirds of the members of the National Board of Directors and an affirmative vote of two-thirds of the chapters voting in the Section in which the Petitioning Group is located. At the National President's discretion, the approval of the National Board of Directors may be by mail ballot with the unanimous written consent of Board members responding within twenty days of the date the petition information is mailed to all Board members. Chapters shall have twenty days from the date the petition information is mailed to them for their vote to be received at the National Office. Voting shall be based upon the recommendation of and upon criteria published by the National Membership and Extension Committee. A negative vote by either a Board Member or a Chapter shall be accompanied by a written explanation of the reasons for such denial, which shall be forwarded to the Petitioning Group within fourteen days for such a vote. Any Petitioning Group denied a charter may then resubmit an application.

### ARTICLE IX — CHAPTERS

#### Section 6. SUSPENSION AND REVOCATION OF CHARTERS.

**Amended by substituting "registered delegates present and voting" for "active chapters registered," so that the section now reads:**

**Section 6. SUSPENSION AND REVOCATION OF CHARTERS.** Charters may be suspended for just cause between National Conventions only after an affirmative vote of two-thirds of the National Board of Directors. A chapter whose charter has been suspended shall still be responsible for meeting its yearly financial, administrative, and annual charter reaffirmation obligations to the National Fraternity, unless deemed otherwise by the National Board of Directors. A charter that has been suspended shall remain suspended until it is reinstated by an affirmative vote of two-thirds of the National Board of Directors or by an affirmative vote of two-thirds of the registered delegates present and voting at the National Convention. A chapter whose charter remains suspended for two years shall be declared inactive as herein prescribed. Charters may be revoked only by a two-thirds vote of registered delegates present and voting at the National Convention. Following revocation of a chapter's charter by a National Convention, no petitioning group shall be recognized nor chapter chartered at that campus for a minimum of two years after the charter's revocation.



## ARTICLE XII — ALUMNI

Section 1. NATIONAL ALUMNI ASSOCIATION. (1) FORMATION.

Amended by striking out the word "all" in the first sentence, so that the sentence now reads: "There shall be a National Alumni Association of Alpha Phi Omega composed of alumni members of Alpha Phi Omega [See Article III, Section 2 (7)]."

Sections 2 and 3.

Amended by substituting "association(s)" for "organization(s)" in all occurrences.

## AMENDMENTS TO THE STANDARD CHAPTER ARTICLES OF ASSOCIATION

### ARTICLE III — MEMBERSHIP

Section 1. OPEN MEMBERSHIP.

Amended to read: "Membership in this chapter of Alpha Phi Omega shall be open to all students. Membership in this chapter shall be granted only upon the approval of the applicant by this chapter and after the applicant has fulfilled the membership requirements prescribed by the National Fraternity and by this chapter."

Section 3. ACTIVE MEMBERSHIP.

Amended by deleting the words "Boy" and "recognized by the International Association," so that the revised phrase now reads: "... who are encouraged, but not required, by this chapter upon activation to be registered members of any Scout movement; ..."

Amended by substituting "an approved membership education program" for "the period of pledge membership," which appeared at the end of the first sentence.

### NEW ARTICLE

Amended by adding a new article as "ARTICLE XVII — SERVICE PROGRAM" and renumbering successive articles accordingly. The new article reads:

#### ARTICLE XVII SERVICE PROGRAM

This chapter shall have a service program for all of its members. The service program shall be planned and carried out such that a reasonable balance is achieved among Alpha Phi Omega's four areas of service, which are:

1. Service to the college;
2. Service to the Fraternity;
3. Service to the community;
4. Service to the nation as participating citizens.

## RESOLUTIONS

ALUMNI resolved that:

■ The National Board of Directors will draft and submit to the 1994 National Convention a comprehensive list of rights, obligations, and privileges that shall be extended to local alumni associations.

■ The Alumni Reference Committee wholeheartedly endorsed the mission statement and the goals and objectives of the National Alumni Committee.

■ The National Alumni Committee is directed to establish by February 1994 a flexible procedure for choosing Regional Alumni Voting Delegates, consistent with the operations of Regional Alumni Councils.

### AWARDS AND APPRECIATIONS:

■ A special certificate of merit is to be established and issued to recognize chapters with outstanding programs of friendship and fellowship. The National Executive Director is to ensure that such certificate is designed and ready for presentation at the 1994 National Convention to chapters selected by the Convention's Awards and Appreciations Committee based on review of applications submitted by chapters. Applications should be no more than fifteen pages each, may include photographs, and must be submitted before the opening session of the Awards and Appreciations Committee.

■ Added to the second criterion for the Josiah Frank Historians Award that video tapes submitted by chapters applying for the award must be no longer than thirty minutes each and will be reviewed by the Awards and Appreciations Committee subject to availability of audio-visual equipment.

■ The National Board of Directors is to re-evaluate the duties of the Awards and Appreciations Committee.

■ Applications for all awards judged by National Convention reference committees (Disborough, Frank, Nowotny, etc.) are to be submitted to the Awards and Appreciations Committee for inspection and distribution to the appropriate reference committees for judging.

- LDW promotional materials sent to chapters be mailed separately from other materials so as to attract more attention.

- A long-range feedback sheet be sent to participating chapters several months after each LDW and CPW.

- More emphasis be placed on small-group interaction and less on large-group lectures.

- The CPW staff be expanded and staff-development seminars be held.

- The "sectional chairs workshop" be promoted as a "sectional staff workshop."

- It is highly recommended that every sectional chair attend at least one "sectional staff workshop."

- A committee be created to develop the Modular Seminars System to a point where it can be adequately reviewed and evaluated by the 1994 National Convention.

- The Chapter Operations Seminar be eliminated as a whole, with its component parts becoming Modular Seminars.

- The president's section of the Leadership Series include basic information on suggested size and composition of the chapter executive board according to the chapter's active membership.

- A Leadership Index be incorporated into each division of the Leadership Series.

- The Leadership Memo be reactivated and published every semester.

- A committee be created to continue building on the existing guidelines for the Friendship Development Workshop.

- Current efforts be continued for publication of the new Advisor's Manual.

- The 1993-94 National Leadership Development Committee evaluate all items referred to in the 1991-92 Leadership Development report submitted to the 1992 National Convention.

### MEMBERSHIP

- A new "ALTERNATIVE NEW MEMBER EDUCATION PROGRAM" was adopted.

- Each regional extension committee is to provide to the National Membership and Extension Committee a unique plan for the education and activation of new and inactive chapters so that a national plan can be developed from the Fraternity's strength and diversity.

- The chair of the National Membership and Extension Committee nominate interested regional membership and extension chairs to positions on the National Membership and Extension Committee.

- The National Membership and Extension Committee is directed to create a new initiation ritual, incorporating current pledge and initiation rituals, for chapters using the Alternative New Member Education Program and to submit such new ritual for consideration by the 1994 National Convention.

- The National Membership and Extension Committee explore ways to stress Extension Membership as an outreach program and to involve Extension Members in their home communities (as opposed to the Extension Members' host-chapter communities).

- The Survival Guide for Small Chapters include a rationale for the adoption of pledge worksheets.

- The Survival Guide for Small Chapters use a less pessimistic tone.

- The suggested service projects cited in the "Q&A" booklet and other

national publications be updated to stress cultural and regional diversity.

- The "Distinguished Alumni" page be updated and reinserted into the Pledge Manual.

- The National Membership and Extension Committee review and amend the Small Chapter Support Program to make it more supportive and less dictatorial, that the Survival Guide for Small Chapters be included in the Petitioning Kit, and that the Survival Guide be revised to include the Small Chapter Support Program.

- The "Service Project Report" form in the charter-application kit include a space for "Contact person (if applicable)" between the spaces for "Project" and "Primary Purpose."

- The "Application for Charter" form be printed on both sides of the page and that the page for the petitioners' signatures be reformatted to allow more room for the signatures.

### NATIONAL ORGANIZATION:

- The following southeastern Wisconsin counties be returned to Region IX and Section 27: Green, Rock, Walworth, Racine, Kenosha, Dane, Jefferson, Waukesha, Milwaukee, Columbia, Dodge, Washington, Ozaukee, Marquette, Green Lake, Fond Du Lac, Sheboygan, Waushara, Winnebago, Calumet, Manitowoc, Waupaca, Outagamie, Brown, and Kewaunee.

- The National Scouting Relations Committee should include executives from all national Scouting organizations, including but not limited to the Boy Scouts of America and the Girl Scouts of the United States of America.

- All chapters are encouraged to continue a program of service to youth, including Scouting.

- The Board of Directors should study alternatives for protecting the capital and real properties of the Fraternity and for minimizing the cost of such protection.

### PUBLIC RELATIONS:

- The National Board of Directors develop and implement a statement of purpose for Fraternity communication/relations.

- The National Board of Directors develop and implement a plan to enhance Fraternity communication/relations, both external and internal, at the national, regional/sectional, and chapter levels.

- Create a public relations newsletter to be distributed to public relations officers at all levels of the Fraternity.

- Distribute copies of national correspondence with university administrators to the chapters at the respective universities.

- Create an alumni tracking database for use with Fraternity communication/relations.

- The National President will appoint a Member-at-Large as chair of the National Public Relations Committee.

- Establish a budget for National Fraternity communication/relations.

### PUBLICATIONS AND MERCHANDISE:

- The Fraternity will design or acquire pictorial representations of the official bird, jewel, flower, and tree and will promote and publicize these designs through means including but not limited to clip art sheets and publications of wide circulation, such as the Pledge Manual; further, brief descriptions of the significance of these symbols will be added to the Pledge Manual.

- A suggestion box with a telephone number and addresses be included on order forms and all catalogues to make it easier for chapters and individuals to make compliments, to offer suggestions, and to express problems.

- Pictorial representation of all-male, all-female, and all-minority chapters be included in future Fraternity publications.

- Beginning with the 1994 National Convention, each reference committee will be given copies of all resolutions relevant to the work of the committee that were considered by the previous convention, with an indication of the disposition of each resolution.

### SCOUTING

Resolved that the National Scouting Relations Committee will pursue the following:

- Inclusion of the following Alpha Phi Omega information in the Boy Scout Handbook, Exploring manuals, Order of the Arrow handbooks, and related literature: an abridged purpose and history, widespread locations, reference to council offices, and the current address of the National Office.

- Efforts to include Alpha Phi Omega articles and references in Scouting periodicals annually, especially in the spring prior to high school graduation. Recommended Scouting publications include but are not limited to Leader Magazine, Boy's Life, Scouting, Scouter's Magazine, and other Scouting periodicals.

- Making a list of ideas and resource materials available to local Alpha Phi Omega chapters to enable them to improve relations with local Boy and Girl Scout councils and other Scouting organizations. These materials should include but not be limited to: how-to books concerning getting involved with Scouting, the availability of a recruiting video, and an up-



dated roster of local Scout council contact persons.

■ Sending information to all chapters about staffing opportunities at all National Boy Scouts of America High Adventure Bases and at local council Boy Scouts of America summer camps and including information, fact sheets, brochures, and any other resource materials about Alpha Phi Omega in staff packets at National High Adventure Bases and, if possible, at local council summer camps.

■ Staffing Alpha Phi Omega information booths at Boy Scouts of America functions designated by the National Scouting Relations Committee (National Council Meeting, Regional Meetings, Order of the Arrow National Conference, National Explorer functions, and the National Boy Scouts Jamboree) and making available a service staff if requested.

■ Creating a survey to be distributed to chapters within one year of the 1992 convention to specifically gather data and contacts regarding chapter activities with and ties to the Girl Scouts of the United States of America. Chapters are strongly advised to participate in this survey.

■ Conducting a survey of Scouting involvement of all Brothers in attendance at the 1994 National Convention:

a) The survey will be used to develop a database on the number of Brothers with a Scouting background. Also, the survey will include the number of Brothers who heard about Alpha Phi Omega through Scouting publications or events.

b) The survey distributed at the 1992 National Convention will be revised to include all Scouting organizations.

c) Upon tabulation of the database, the information will be shared with any interested representatives of Scouting organizations.

■ Examining and investigating possible opportunities to extend Alpha Phi Omega's involvement in international events which follow and promote the ideals of Scouting (The Rover Moot, International Summer Camp Staffing, and World Scout Jamboree).

■ Altering the chapter reaffirmation form to include the following question below the request for a name of a chapter's Scouting advisor: "Do you wish the National Scouting Relations Committee to contact your Scouting advisor concerning guidelines for the relationship with the chapter and resources available?"

■ Inviting all Scouting organizations to submit articles to be printed in Alpha Phi Omega publications.

■ Learning more about other Scout groups (e.g., Camp Fire) regarding their goals, membership, ages, history, and opportunities available within and initiating dialogue with these organizations.

■ Further resolved that:

■ A letter of appreciation be sent to Ben Love for his years of service to Alpha Phi Omega and his vital input to the relations of the National Fraternity with the Boy Scouts of America.

■ A letter of appreciation be sent to Elayne Dorsey for her participation as a representative of the Patriot Trail Girl Scout Council in the Volunteer Fair held at the 1992 National Convention.

■ A letter of appreciation be sent to Boy Scouts of America Troop 11 and Girl Scouts of the United States of America Troop 111 for their participation in the color guard ceremony preceding the opening session of the 1992 National Convention.

## LONG-RANGE PLANNING

The Convention received the report of the Long-Range Planning Reference Committee, which revised the Fraternity's "Focus: 21" goals for review by the National Board of Directors.

## TOAST SONG

The 1992 National Convention resolved that the following proposed Third Verse be presented for consideration by the 1994 National Convention:

*Sing we now, both men and women,  
Brothers all are we.  
Hearts as one, we praise together  
Our diversity.  
Ever growing, ever learning,  
So that we may be  
Joined in Alpha Phi Omega  
For eternity.*
