

Wilfred M. Krenek was elected by acclamation as National President by the delegates at the 1994 National Convention in Dallas, Texas.


Activated in 1971 into Alpha Rho Chapter at the University of Texas at Austin, Wilfred served in various chapter offices as well as Chapter President. After receiving a Bachelor of Business Administration degree, he served as Chair of Section 42, from 1977-1980. At the 1980 National Convention, Brother Krenek was elected Region VII Director and was subsequently re-elected in 1982, 1984, and 1986. He became a Member-at-Large on the National Board of Directors at the 1988 National Convention in Denver and chaired the National Finance Committee for two years. He was elected National Vice President in 1990 and was re-elected in 1992.

Wilfred coordinated the 1986 National Convention in Houston, Texas and served as an advisor to the 1988 and 1990 National Conventions. He chaired the National Executive Search Committee in 1984 and later co-chaired the "Target 30" fund-raising effort for the National Headquarters building of the

International Agreement

The words in this article are those of Gerald A. Schroeder, our National President 1990-1994. The occasion was our 1994 National Convention held in Dallas-Ft. Worth, Texas. It was at our Awards banquet that the International Council of Alpha Phi Omega was brought to fruition.

December 30, 1994

Ithough we were not in Brainard Hall in 1925 when Alpha Phi Omega was founded, or at Far Eastern University in the Philippines in 1950 for the first sign of international expansion, we are here today to witness the birth of a new organization, the International Council of Alpha Phi Omega.

As the relationship between Alpha Phi Omega of the USA and Alpha Phi Omega of the Philippines grew, expansion activities began increasing on an international scale. Visionaries in both of our fraternities, quite correctly in my view, believed that an organization, composed of representatives of each independent national Alpha Phi Omega fraternity, would be helpful to improve communication and aid in international expansion efforts.

At this moment, Felix Marinas, National President of Alpha Phi Omega of the Philippines, (known as Chato to his friends) and I will sign the document bringing such an organization to life.

As the ideals and spirit of Alpha Phi Omega continue to spread around the world, the International Council of Alpha Phi Omega, which is loosely based on the World Council of Scouting, will welcome into the Council all new national APO organizations.

It seems appropriate at this time to hear Frank Reed Horton's own words: "My purpose was to make Alpha Phi Omega an organization that cooperated with all youth movements, especially Scouting. I also anticipated that our service program would expand to help people in need everywhere.... As Scouting is worldwide, so should Alpha Phi Omega be worldwide."

Tonight is the result of years of negotiations and hard work. Past President Earle Herbert chaired the International Concerns Committee for most of the last ten years and devoted much energy to this effort. Last December, some four months before his death when we were with Chato in California, Earle sensed that this moment was near and was clearly elated. Chato also deserves great credit for this moment, for it is a direct result of his vision and brotherhood and that of the brothers and sisters of APO Philippines. The cardinal principles of Alpha Phi Omega know no national boundaries, and you have proven it!

This is truly an historic moment, and I am excited and proud that we will all be able to witness it. It is truly an extension of Frank Reed Horton's dream.



LEADERSHIP


During the convention we conducted four Leadership Development Workshops. Almost 200 Actives gain skills that will help them as future Chapter leaders and in their lives to come.






